KSU receives unmodified audit opinion from COA

The Kalinga State University received its third unmodified COA opinion during the term of Dr. Eduardo T. Bagtang as President having satisfied the state auditor in all material respects, which means compliance in form and content with all statutory accounting and auditing rules and regulations of the agency's true and fair reflection of its financial condition, position, and operations.

Through an Independent Auditor's Report dated March 15, 2022 and addressed to the university president, Commission on Audit - Cordillera Administrative Region OIC Supervising Auditor Isidora E. Fernandez opined that "the accompanying financial statements present fairly, in all material respects, the financial position of KSU as of December 31, 2021, and its financial performance, its cash flows and its comparison of budget and actual amounts for the year ended in accordance with the International Public Sector Accounting Standards (IPSASs)".

The commission's unmodified opinion is in accordance with the ethical requirements that are relevant to the audit of financial statements wherein the audit evidences obtained are sufficient and appropriate to serve as basis of the report. This clean opinion from COA means that the auditor believes that the statements presented follow IPSASs and are free from material error. "Our receipt of COA's unmodified opinion for the third time is testament to KSU's integrity and commitment to uphold transparency and accountability in all our financial activities, even during challenging times as the Covid-19 Pandemic," Dr. Bagtang said.



Popoy De Vera is "Alingag", adopted son of Kalinga

Through SP Resolution No. 2022-046, Commission on Higher Education (CHED) Chairman J. Prospero E. De Vera III was adopted as son of the Province of Kalinga and dubbed him Alingag which means "to re-echo".

The adoption of De Vera was conferred by Provincial Governor Ferdinand B. Tubban in the presence of some members of the Sangguniang Panlalawigan, KSU President Dr. Eduardo T. Bagtang and other guests during the cultural night held at the University Gymnasium last March 2, 2022 on the occasion of his visit to Kalinga State University.

According to the resolution, being an adopted son of Kalinga is a time-honored tradition of the

According to COA, unmodified opinion is similar to unqualified opinion, the best auditing mark which can only be achieved if an entity's financial statements are free from "material misstatements".

COA's annual audit ensures that government offices adhere to the province and in consonance with customary indigenous ethnic practices and personages and is conferred to individuals who have singularly endeared themselves and contributed outstanding services to the people. The resolution further stated that "De Vera serves as an academician technical whose expertise helped policy-makers for the passage of legislative measures in educational development and other public services".

Sons and daughters of the province are granted certain privileges including protection under the auspices of the Kalinga Peace Pact institution of the Bodong Justice System through the Pagta, the law of the Bodong. /R. Wacas

As earlier said, it is really a great opportunity to be visited by a high ranking official in the Commission to grace the program especially when he highlighted the tertiary education subsidies (TES) and the government's Tulong Dunong Program where all KSU students are beneficiaries of TES and many are beneficiaries too of Tulong Dunong. This is a challenge then on the part the student recipients. Do your part in finishing your degrees on time and not to take it for granted. That is the investment of the government. In return, it should be spent well. That is your counterpart as beneficiaries of the said program. Do embrace whatever programs of the government particularly the CHED, that benefit each student. Aside from his visit to KSU, he is scheduled to visit the different SUCs and LUCs in the Philippines to monitor the plight of the TES beneficiaries. Most students in the tertiary level are enjoying free education as well emphasized and more than two million Filipino students have, so far, benefitted from the free quality tertiary education act signed in 2017.

Of the reported number, 1.97 million students across 220 higher education institutions did not have to pay tuition and miscellaneous fees from the academic year (AY) 2018-2019 up until AY 2021-2022.

Meanwhile, a total of 364,168 grantees benefitted from tertiary education subsidies (TES) and the government's Tulong Dunong Program in the same period.

Republic Act 10931 or the "Universal Access to Quality Tertiary Education Act" exempts eligible college students enrolled in a bachelor's degree, certificate degree or any comparable undergraduate degree from paying tuition and other school fees.

"This landmark legislation is truly only and exclusively a tatak Duterte (Duterte's brand) because it was started under the Duterte administration [and] allowed public universities...to launch a program in 2018 that allowed every young Filipino to dream and achieve their education," De Vera said during the visit.

RA 10931 did not only benefit state universities and local colleges, noting that majority or around 68% of the grantees of the TES and Tulong Dunong came from private schools.

According to De Vera, the

poverty incidence rates among families in regions where TES beneficiaries live, went down in the first semester of 2021, in the Bangsamoro Autonomous Region of Muslim Mindanao, Zamboanga Peninsula and Eastern Visayas, among others. These areas experienced a rise in TES grantees since the RA 10931 was enacted. To this program, students and parents are very lucky enough because tuition fees and other miscellaneous fees are no longer their problems. These fees are taken care of by the government. This is to help most Filipino youth finish their respective degrees.

The Senate and House had their own versions of a measure which sought for free quality tertiary education for all students based in state universities and colleges through a full tuition subsidy. The disagreeing provisions of both bills were ironed out by a bicameral conference committee. Duterte eventually signed the consolidated version into law on Aug. 15, 2017.

It is concluded that the visit of De Vera in the Province of Kalinga is very inspiring hence he gave full support to this TES program of the government. Thus, through SP Resolution 2022-046, he was adopted son of the province of Kalinga and dubbed him Alingag which means to "echo". He is to echo all the programs of the Commission on Higher Education. Kudos CHED Chair De Vera, saludo po kami sa inyo!

KSU BOR approves revised graduate programs curriculum, MPA Major in Procurement new program offering

The KSU Board of Regents approved the revision of the Curricular Offerings of the Graduate Programs, namely: Ph. D. in Community Development, Ph. D. In Educational Development, Master of Science in Rural Development, Master in Public Administration, Master in Business Administration, Master of Arts in Education with majors in Educational Management, Mathematics, Social Studies, Filipino, and English.

Part of the revision in the curriculum across the graduate courses is the enhancement of research capability of the students with the inclusion of the requirement for publication in a refereed or CHED-recognized research journal.

The Board also recommended the inclusion of a three-unit cognate subject; that according to Commissioner Canapi would complete the framework for the course this would be helpful in the formulation of the problem for the thesis/research work of the students.

The Board also approved the new offering of Master in Public Administration major in Procurement which will be offered effective School Year 2022-2023.

In an interview with President Eduardo T. Bagtang, the offering of MPA major in Procurement is an offshoot of the partnership of KSU with the Government Procurement Policy Board of which KSU is tapped as a training arm for Procurement Specialists; hence the formulation of procurement as a major under MPA.

KSU launches MIS online enrolment for S.Y. 2021-2022

Kalinga State University's online enrollee update, out of 2,078 students, 1,834 (88.26%) have officially enrolled on the Management Information System (MIS). This MIS is primarily for first-year regular college students only.

University's online enrollment systems vary from SIAS to SARIAS to MIS. And the Management Information System (MIS) is the system currently in use. It features an automated system for student information and accounting, but it is not online-capable. The system can only be accessed when a user is on university grounds. "Collaboration is used to create MIS. The system incorporates SIAS (old system) and SARIAS (system before MIS) best practices and user feedback on the system's functionality. As a result, it was developed through the collaborative efforts of all target consumers", a quote from Sir Reymar Pan-oy, the MIS's sole developer/programmer.

"The shift is aimed at achieving our university's VMGO. It became a reality due to the rapid advancement of technology and the demands of users. Because of the COVID-19 Pandemic, the university was forced to shift to an online platform to address concurrent concerns/issues caused by the Pandemic. The current platform at our university is incapable of addressing these concerns. Hence, we switched from SIAS to MIS," he added.

KSU's online radio on its way for operation

The Board of Regents has approved the proposal from the office of the University president, Dr. Eduardo T. Bagtang, for a one (1) million budget of the online radio under Board Resolution no. 2 series of 2021. It is now on its halfway to installation. It will cater to the laboratory needs of the Bachelor of Science in Development Communication Program, particularly in their Community Broadcasting. serve as an avenue for online classes of all colleges within the University.

The Development Communication Department will handle its management and Operation under the College of Agriculture, headed by Dean Rex S. Langngag. Technically, the office of the Director for ICT, under Director Giarhard Awis is in charge of the maintenance of all the technical functions. In coordination with the University President, it is recalled that the same office worked to realize this proposal from planning, assessment of needs, justification, PPMP, procurement of equipment until its implementation.

In pursuit of its goal to establish a reputation as a Center for Indigenous Studies, Kalinga State University put forward a and was able to gain the Commission on Higher Education (CHED) National Vetting Panel's approval for the proposal to establish a Campus-based Kalinga Cultural Heritage Studies and Edu-tourism Center to institutionalize learning ues/centers for the perpetuation of Indigenous Kalinga People's culture and provide experiential learning for participants of the StudyPh Program.

With this project, KSU is granted with the amount of sixteen million pesos (16M) as funding assistance for the implementation of the approved project.

This project will pave the way for the (1) refurbishing of existing

facility (2) development of standardized packages of teaching/learning materials (3) capability-building, and (4) partnership development for internationalization.

The project seeks to strengthen the internationalization program of KSU by institutionalizing a learning center for the perpetuation and dissemination of Kalinga culture that can be accessed both physically and virtually.

The project is spearheaded by Dr. Jessie M. Sannadan with Dr. Ma. Cyrila C. Bawer, Dr. Joy Grace P. Doctor, Dr. Divina A. Balocnit, Dr. James S. Guidangen, Dr. Marilou B. Adora, Dr. Sheila Mae Carol A. Buslig, Mrs. Odette C. Pannogan and Dr. Pinky Larcelle L. Gas-ib. Groundbreaking for the project was done on March 2, 2022 with the CHED Chairperson J. Prospero De Vera III, CHED Regional Director Demetrio Anduyan Jr., Dr. Eduardo T. Bagtang among others gracing the occasion.

KSU engineering lab equipment to go global

Kalinga State University Board of Regents approved on July 7, 2021, by Administrative Council Resolution no. 24, S. 2021 the 21.3M budget for the Modernization of Engineering Laboratory Equipment that is funded by the Commission on Higher Edu-

The said program was proposed by the College of Engineering and Information Technology (CEIT) headed by the college's dean, Engr. Rhonjhon R. Garming who is in charge of its implementation. "The program not only aims to upgrade the University's engineering laboratory facilities but more importantly, to produce quality graduates and promote educational excellence in the University," stated Dean Garming. "These, of course, can be realized by delivering quality instruction in order to achieve the core competencies expected from our students." he further

The laboratory upgrade shall feature a small-scale structural behavior laboratory, which includes structural hardware, display, visualization software, instrumentation package, analysis software: and a subsonic wind tunnel of 305 x 305 mm, with versatile data acquisition with its components./ MJ Garming


CHED grants 25M; KSU to optimize university network



REPIC sets procedures on publication

The Research and Extension Publication Information Center surely aims to properly organize, document and monitor publication ventures of Kalinga State University faculty-researchers as it had set official procedures to be followed once a research paper is accepted for publication in any local and international journal.

REPIC Director Karen Duyan shared that there had been a difficulty in monitoring the number of faculty-researchers who are able to submit research papers for publication thereby creating confusion in securing reimbursements of publication fees once these are accepted.

The REPIC now requires faculty-researchers to accomplish the application for publication, certification and copyright form to ensure that all publication endeavors are recorded, that the journal is a refereed or indexed journal and not included in the Beall's List of Predatory Journals or Publishers, that the paper was during review and was written at least three (3) years back, and that the paper is free from copyright infringements and plagiarism issues.

This shall be noted and certified by the College Research Chair, the University Research Publication Chairman, and the Senior Research Specialist before the approval of the REPIC Director.

The form along with the notice of acceptance from the journal indicating the fees and payment procedures, the published paper, the reviewer's comments and suggestions (if any) and a letter of request for reimbursement or financial assistance relevant to the publication will be forwarded to the Research Development and Extension Office./ R. KSU notches 101-200 in WURI rankings



With the Kasupang program as its highlight for the crisis management category, the Kalinga State University scored a place in the Top 101-200 of the 2022 World's Universities with Real Impact (WURI) Ranking.

WURI is a new international ranking established by the Organizing Committee of the Hanseatic League of Universities (HLU).

This year's ranking was organized by the Policy and Strategy on National Competitiveness (IPSNC) of South Korea and supported by four other organizations including the United Nations Institute for Training and Research (UNITAR), HLU, the Institute for Industrial Policy Studies (IPS) from Seoul, South Korea, and the Taylor Institute of Franklin University Switzerland (FUS) from Switzerland.

The ranking seeks to deviate from the traditional rankings by highlighting the innovative programs of the universities instead of the usual quantitative metrics which give credence to research and academic systems.

Kasupang as the univ's innovation entry

KSU emphasized the innovation it implemented during the onslaught of the COVID-19 pandemic which debuted in March 2020.

Kasupang is the term used to refer to KSU's action frontline against the pandemic.

It is a Kalinga ethnic term that means "counterpart" and an appellation conferred to peace pact holders to acknowledge their incredibly significant task to triumph and uphold peace and order between and among their tribes.

KSU became a "kasupang" of the government in planning and organizing a series of activities based on the resources and technical competence available to help mitigate the impact of the health threat.

The university kicked off the program with relief operations to the application and implementation of research outputs.

The technical competence of its employees led to the development of Ethyl alcohol, calamansi soaps, aloemon hand sanitizers, washable face masks and calamansi cookies which were distributed to different groups of front liners and communities.

Along with these contributions were the following: implementation of the flexible learning
continuity plan where teachers
and students were introduced to
synchronous and asynchronous
teaching-learning process,
printing and distribution of IEC
materials on COVID-19, transportation services and scheduled
decontamination of the three
campuses of the university.

The Kasupang program is still implemented and will continue until the pandemic ends.

KSU's next plan for WURI

According to Dr. Pinky Gas-ib, the Director for the Office of Distance Education, Transnational Education and International Linkages, the university seeks to notch up in next year's WURI rankings and plans to work on programs under the other categories.

The six (6) criteria under the ranking include Industrial Application, Entrepreneurial Spirit, Ethical Value, Student Mobility and Openness, Crisis Management, and Fourth Industrial Revolution.

Gas-ib added that a committee for the WURI 2023 which shall spearhead the planning, monitoring, evaluation and preparation of documents is now suggested.

"With this achievement, the university through the ODETEIL and the Office for Quality Assurance, dreams more in its internationalization plans looking forward to qualifying in other university ranking standards and criteria like Times Higher Education World University Rankings and QS World University Rankings," Gas-ib shared.

It is further noted that KSU shall send delegates to the CHED-Cordillera's first-ever masterclass titled, FLAIR: "Filipino Leaders in Advancing International Reputation" on June 28-30 in Baguio City. This event aims to work together with the different Cordillera HEIs in showcasing their uniqueness and their contributions to the region, the country and the world./Rladwingon



DOST-PTRI launches sericulture facility in KSU-Rizal Campus







The Philippine Textile Research Institute (PTRI), the premier textile research and development arm of the Department Science and Technology (DOST) inaugurated the first ever Silk Filature Facility installed at the Kalinga State University, Campus in Barangay Bulbul, Rizal, Kalinga last April 29, 2022. The momentous event was graced by PTRI Director Celia B. Elumba, DOST-CAR Regional Director Dr. Nancy A. Congressman Jesse C. Mangaoang, KSU President Dr. Eduardo T. Bagtang, University Officials and other stakeholders including LGU-Rizal Officials, members of the Kalinga Indigenous Weavers Association (KINWA), Sagada Weavers and other farmers and non-government organizations

Earlier in 2017, a one-hectare mulberry plantation was initially prepared at the KSU-Rizal Campus which was later expanded to 10 hectares to produce mulberry leaves, the primary food source of silkworms for cocoon production. A silkworm rearing and cocoon processing facility was later put up at the KSU Rizal Campus with the aid of

the PTRI and the Philippine Fiber Industry Development Authority. In his message, Congressman Mangaoang emphasized the importance of the project as it will open up new beginnings for sericulture farmers as well as the Kalinga weavers who used to source out their indigenous raw materials from banana, cogon, abaca and maguey.

"Weaving is one of the major activities economic among women in the province of Kalinga and I believe that the production of silk through this facility will provide additional raw materials for Kalinga weavers and will further improve the quality of the Kalinga textile which is included in the world's list of renowned woven products. In addition to providing livelihood opportunities for farmers and weavers in the province, we can see a huge potential for the silk farm to be a sustainable and viable tourist destination for both local and foreign tourists." Mangaoang said.

Meanwhile, PTRI Director Celia B. Elumba expressed her gratitude to the Kalinga State University and the Local Government Unit of Rizal for their unwavering support that contributed to the establishment and inauguration of the Silk Filature
Facility which did not fully operate during the last two years because of the Covid-19 Pandemic.
She likewise underscored that
the project will provide opportunities for weaving communities
to enhance their talents and
transform their simple products
into world class products.

Sericulture is the process of farming silkworms. It starts with the cultivation of Mulberry trees. the leaves of which are the silkworm's food. After twenty-one days of feeding, the silkworms spit out silk cocoons which are turned into fiber and thread. The silk reeling line at Kalinga State University will serve as the silk research and innovation center (SRIC) in the Cordillera. It will integrate activities for silk cocoon production from the surrounding areas and rural communities for processing. The facility is expected to redound to more involvement of stakeholders to create jobs through moriculture, cocoon production, cocoon processing, and weaving.

KSU reopens campus for LF2F lab courses

Kalinga State University has started its limited face-to-face classes for the BS Midwifery and Diploma in Midwifery programs of the College of Natural and Health Sciences in February 2022, almost two years after the Luzon-wide lockdown due to the COVID-19 outbreak.

The college has allowed the in-campus classes for laboratory subjects and demonstration sessions with only ten students in a room. CNHS students attended their limited face-to-face classes at the Bulanao Campus, where they performed returned demonstrations on clinical practicum.

According to Dr. Divina A. Balocnit, the CNHS Dean, students' off-campus training started in September 2021 when the CHED awarded the "Certificate of Authority" to Conduct Limited Face-to-Face classes to both courses.

"The face-to-face classes are needed especially in returned demonstrations. Our students must be prepared and ready before being deployed to the hospitals for their off-campus training. The students must be well equipped with necessary skills needed in the field. " Dean Balocnit said in an interview.

Geraldine L. Liwaliw, CNHS clinical instructor, said that this is the students' first time to hold mannequins and perform proper procedures because during flexible learning classes, students can only practice with their stuffed toys without the proper laboratory equipment and medical tools.

"Ang challenging part doon (flexible learning) ay you cannot build rapport and trust with your students because virtual - walang proper communication. Unlike kapag face-to-face, you see your students and you can teach them properly and correctly the different procedures," Liwaliw said in an interview. »P.20

Like Fevie Joy P. Babalan, midwifery student, other students also hope for the continued face-to-face classes after these demonstrations.

"Iyong mga concepts po na itinuro, magagawa na po namin kasi may mga gamit na po kami kaysa kapag nasa bahay lang kami na laging nag-iimprovise ng mga magagamit. Pero yung iba po, hindi po naiintindihan kasi mahirap pong makita sa screen kung ano po yung mga ginagawa katulad po nung sa pagpapaanak po, hindi gaanong malinaw".

Another lecturer from the college, Ms. Evejoy Sulca, who took part in the pilot run of onsite classes, shared the disadvantages of online classes to Midwifery students.

"Siyempre kapag online, hindi mo lahat matuturo sa mga students lalong-lalo na sa mga skills na kailangan nilang matutunan. Sila sa bahay nila, wala silang ganitong set up; 'yong mga instruments wala sila, so ang benefit na magka-face- to-face ulit ay magkakaroon sila ng hands-on experience doon sa mga skills na kailangan nila," Sulca said in an interview.

Aside from limited face-to-face classes, the college will also conduct in-person midterm examinations this March. Furthermore, laboratory courses for the College of Engineering and Information Technology and the College of Agriculture are planned to reopen soon.
