

CONTRACT AGREEMENT

THIS AGREEMENT, made this 14th day of **September 2023** between **KALINGA STATE UNIVERSITY** with principal office address at National Highway, Purok 6, Bulanao Centro, Tabuk City, Kalinga (hereinafter called the "Entity") and **JMCWELLS ENGINEERING CONSTRUCTION & DEVELOPMENT** with office address at Purok 5, Bulanao Centro, Tabuk City, Kalinga Province (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **REPAIR OF FLOOR TILES, DOORS, CANOPY & PLUMBING WORKS AT LAW BUILDING** / Project Identification No.: NNP_CIVILWORKS_2023-08-083 (hereinafter called "the Works") and the Entity has accepted the Bid for **FIVE HUNDRED FOURTEEN THOUSAND, ONE HUNDRED SEVENTY PHILIPPINE PESOS AND NINETY-SIX CENTAVOS (PHP 514,170.96)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

a. Philippine Bidding Documents (PBDs);

i. Eligibility/Technical Documents:

- 1) CY 2023 Mayor's/Business Permit
- 2) Valid PhilGEPS Registration Number
- 3) Philippine Contractors Accreditation Board (PCAB) License
- 4) Income/Business Tax Return
- 5) Duly signed PROJECT REQUIREMENTS, which shall include the following:
 - a) List of Contractor's Key Personnel to be assigned to the Contract to be bid, with their complete qualification and experience data, as follows:
 - ✓ Key Personnel's Bio-data
 - ✓ Key Personnel's Certificate of Employment
 - b) List of contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by Proof of Ownership or Certification of Availability of Equipment from the equipment lessor/vendor for the duration of the Project (SF-INFR-49)
- 6) Original duly signed revised Omnibus Sworn Statement (OSS)
- 7) Integrity Pledge for KSU Service Provider and AMO's valid Identification

ii. Financial Documents:

- 1) Original of duly signed Bid Prices in the Bill of Quantities (BOQ).
- 2) Duly accomplished DETAILED ESTIMATES, including a Summary Sheet indicating the unit prices of construction materials, labor rates, and equipment rentals used in coming up with the Bid.

- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

c. Performance Security;

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the **PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **FIVE HUNDRED FOURTEEN THOUSAND, ONE HUNDRED SEVENTY PHILIPPINE PESOS AND NINETY-SIX CENTAVOS (PHP 514,170.96)** or such other sums as may be ascertained, **JMCWELLS ENGINEERING CONSTRUCTION & DEVELOPMENT** agrees to execute and complete the Works and remedy any defects therein in accordance with its Bid.
4. The **KALINGA STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
