# A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF A CONTRACT FOR THE PURCHASE AND DELIVERY OF PROFESSIONAL BOOKS

BAC Resolution No. 293 Series of 2023

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website (https://notices.philgeps.gov.ph/) on March 15, 2023, to April 4, 2023, for the bidding of Purchase and Delivery of Professional Books with an Approved Budget for the Contract (ABC) amounting to One Million Five Hundred One Thousand Three Hundred Ninety-Seven Philippine Pesos (Php 1,501,397.00) sourced from Internally Generated Fund (IGF) for CY 2023 and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, eleven (11) prospective bidders, namely: Megatexts Phil. Inc., Bigfaith Trading, New Century Books & Gen. Mdse., Great Books Trading, Mind Mover Publishing House, Inc., Forefront Book Co., Inc., Belview Co., Inc., Wiseman's Books Trading, Inc., EESM Bookstore, NSGB Books Trading, and Infopage Education Services, Inc., browse/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Goods (TWG-Goods) conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/eoj-stakesp, with the bidder's representatives on March 23, 2023, @ 10 am whereupon Supplemental Bid/Bulletin (SBB) No. 01 dated 23 March 2023 was issued to amend the contents of bidding documents, particularly on Item and Description of Technical Specifications of the project;

WHEREAS, one (1) bidder, namely: Great Books Trading, purchased the bidding documents on March 28, 2023, respectively;

WHEREAS, one (1) bidder, namely: Great Books Trading, had submitted its bidding documents containing the technical and financial documents before the scheduled time;

WHEREAS, during the Opening of Bids on April 4, 2023, the BAC, upon the recommendation of the TWG-Good, declared the bids of Great Books Trading as "eligible" and passed the technical evaluation of the bidding;

**WHEREAS**, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Great Books Trading as "**complying**" and further proclaimed as the Single Calculated Bidder. The bids, as calculated, are as follows:
