



**A BAC RESOLUTION DECLARING POST-QUALIFIED BIDDER AND RECOMMENDING AWARD OF CONTRACT FOR LOT 2: PRINTER WITH COPIER AND SCANNER OF THE PROCUREMENT OF CY 2022 IGI-FUNDED ICT EQUIPMENT IN COMPLIANCE TO REPUBLIC ACT NO. 9184 AND ITS 2016 REVISED IMPLEMENTING RULES AND REGULATIONS**

**WHEREAS**, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website: <https://notices.philgeps.gov.ph/> on **November 9-29, 2022** for the bidding of the following packaged lots for **Procurement of CY 2022 IGI-Funded ICT Equipment** with a total Approved Budget for the Contract (ABC) amounting to **Four Million, Five Hundred Seventy-Three Thousand, Three Hundred Three Philippine Pesos (Php 4,573,303.00)** sourced from **Internally Generated Income (IGI) Fund for CY 2022** and posted the same at the KSU Website: <https://ksu.edu.ph/bid/procurement-cy-2022-igi-funded-ict-equipment>, and conspicuous place at the premises of the University Campuses, continuously for **seven (7)** calendar days after its first failed bidding conducted for the period October 5-25, 2022.

**WHEREAS**, in response to the said posting/advertisement, **sixteen (16) prospective bidders**, namely: Kitrix Computer Corporation, DCI Int'l. I.T. Solutions and Services Corporation, Agile Techfrontier Corp., LSI Leading Technologies Inc., Cosmotech Philippines, Inc., Accel Prime Technologies Incorporated, Annex Digital, Incorporated, Need Ink Sales & Services, Pronet Systems Integrated Network Solution Incorporated, GNF General Merchandise, Philcomp Enterprises, Datacore Technologies Inc., Hytec Power, Inc., Juan Book Store, PCNET Computer Trading and Services, Hexatronics Marketing browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

**WHEREAS**, the Bids and Awards Committee (BAC) and the Technical Working Groups (TWG) for IT and Laboratory related Supplies and Equipment conducted the **Pre-bid Conference** including **online** via Google Meet link: [meet.google.com/zdc-ousw-qfc](https://meet.google.com/zdc-ousw-qfc) with the prospective bidders and bidder's representatives on **November 17, 2022 @ 10:00 am** whereupon **Supplemental Bid/Bulletin (SBB) No. 01 dated November 21, 2022** were issued to amend the contents of bidding documents including the schedule of the bid opening;

**WHEREAS**, as per records of the BAC Secretariat, **only one (1) bidder purchased the bidding documents**, namely: Pronet Systems Integrated Network Solution, Inc.;

**WHEREAS**, Pronet Systems Integrated Network Solution, Inc., submitted their bid documents containing the technical and financial documents before the scheduled time;

**WHEREAS**, during the **Opening of Bids on November 29, 2022 @ 10:01 am**, the BAC, upon the recommendation of the TWG for IT related Supplies and Equipment, declared the bids of Pronet Systems Integrated Network Solution, Inc., as **"eligible"** and passed the technical evaluation of the bidding for Lot 2- Printer with Copier and Scanner;

**WHEREAS**, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Pronet Systems Integrated Network Solution, Inc, as **"complying"**, and further proclaimed as the Single Calculated Bidder and the bids as calculated are as follows:






By the power vested in me by the Kalinga State University Board of Regents, I hereby:

  - Section 35.1(b), 2016 R-IRR of RA 9184: **Bids received, but no one was eligible.**
  - Section 35.1(c), 2016 R-IRR of RA 9184: **All bids failed to post qualify.**
  - Section 35.1(d), 2016 R-IRR of RA 9184: **Someone post qualified but refused without justifiable cause to accept the award.**
- SUBJECT FOR RE-BID** based on the following:
- Section 35.2, 2016 R-IRR of RA 9184: **Task the BAC and TWG to conduct mandatory review and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents.**
  - Section 35.3, 2016 R-IRR of RA 9184: **To task the BAC to conduct a re-bidding with re-advertisement and/or posting.**
  - Section 35.5, 2016 R-IRR of RA 9184: **To resort to negotiated procurement, specifically Two Failed Biddings (Sec. 53.1).**
