A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE REPAIR OF LADIES DORMITORY OF BULANAO CAMPUS PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

**BAC Resolution No. 029
 Series of 2023**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPs Website (<https://notices.philgeps.gov.ph/>) from December 30, 2022, to January 10, 2023, for the bidding of **Repair of Ladies Dormitory of Bulanao Campus** with an Approved Budget for the Contract (ABC) amounting to **One Million, Nine Hundred Fifty-One Thousand, Seven Hundred Fifty Philippine Pesos and Fifty Centavos (Php 1,951,750.50)** sourced from Internally Generated Income (IGI) Fund for CY 2022, and posted the same at the KSU Website (<https://ksu.edu.ph/>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, two (2) prospective bidders, namely: DELTA JO CONSTRUCTION (DELCONS), and BANGYAN 3D CONSTRUCTION browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/zaq-yrrd-ftb, with the bidder's representatives on January 11, 2023 @ 10 am whereupon Supplemental Bid/Bulletins (SBB) No. 01 dated January 13, 2023 was issued to amend the contents of bidding documents, particularly on the project requirements;

WHEREAS, only one (1) bidder, Mighty Stellar Development Construction, purchased the bidding documents on January 19, 2023;

WHEREAS, during the **Submission and Receipt of Bids on January 23, 2023**, only Mighty Stellar Development Construction, submitted its bid documents containing the technical and financial documents before the scheduled time;

WHEREAS, during the **Opening of Bids on the same day, January 23, 2023 @ 10:01 am**, the BAC, upon the recommendation of the TWG-Infra, declared the bids of Mighty Stellar Development Construction as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids of Mighty Stellar Development Construction as "complying", and further declared its bid as Single Calculated Bid with an amount of One Million, Nine Hundred Forty-Seven Thousand One Hundred Forty-Seven Philippine Pesos and Fifty-Six Centavos (Php 1,947,147.56) subject to the conduct post-qualification evaluation;

WHEREAS, the TWG-Infra, upon the conduct of **Post-qualification Evaluation** by the Post Qual Team on January 25, 2023, recommended to the BAC to declare the bid of Mighty Stellar Development Construction as the **Single Calculated and Responsive Bid (SCRB)**;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infra, **hereby recommends for approval by the University President to declare the bid of Mighty Stellar Development Construction as Single Calculated and Responsive Bid (SCRB) and to award the contract amounting to One Million, Nine Hundred Forty-Seven Thousand, One Hundred Forty-Seven Philippine Pesos and Fifty-Six Centavos (Php 1,947,147.56) for the project: Repair of Ladies Dormitory of Bulanao Campus.**


