BAC Resolution No. ______ 19 Series of 2023 WHEREAS, the Kalinga State University (KSU) seeks to attain economy and efficiency in all aspects of its procurement operations by resorting to an Alternative Method of Procurement (AMP), specifically: Small Value _ consistent with Rule XVI of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act (RA) No. 9184; WHEREAS, the KSU Bids and Awards Committee (BAC) was tasked to evaluate the Purchase Request No. 1021 - 12 - 0709 , for the procurement of [] goods [] consulting services [] civil works; WHEREAS, to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions stated in the RFQ, the BAC, with the assistance of the Technical Working Group (TWG), has undertaken the following Post Qualification proceedings, as applicable: The BAC has determined whether KSU is entering into a contract with a capable Supplier, Consultant, or Contractor by requiring the submission of applicable eligibility, technical and financial documents concerning Appendix A of Annex H, 2016 R-IRR of RA 9184 of the Documentary Requirement for AMP. 2. The BAC has verified, validated, and ascertained the bidder's bid price proposal and the required financial requirement to ensure sustenance of the transaction's operating cash flow once this project is awarded.
