## BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT AND HOPE APPROVAL (for RFQs with ABCs with ≤Php 50,000.00)

BAC Resolution No. 186  
Series of 2021

WHEREAS, the Kalinga State University (KSU) seeks to attain economy and efficiency in all aspects of its procurement operations by resorting to an Alternative Method of Procurement (AMP), specifically: SMALL VALUE consistent with Rule XVI of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act (RA) No. 9184;

WHEREAS, the KSU Bids and Awards Committee (BAC) was tasked to evaluate the Purchase Request No. 2021-09-0204, for the procurement of  goods  consulting services  civil works;

WHEREAS, to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions stated in the RFQ, the BAC, with the assistance of TWG, has verified the following applicable Justifications as part of Post Qualification proceedings:

- 1. The amount involved is equaled to Php50,000 and below, which is a small amount to qualify for public bidding conduct and falls under the exception to the exception as cited in the Consolidated Guidelines for Alternatives Methods of Procurement, Annex "H" of the 2016 IRR.
- 2. There is unforeseen contingency requiring immediate procurement of goods, services, or civil works.
- 3. It will accelerate speedy processing because posting advertisements for days at PhilGEPs and KSU websites and conspicuous places of the University may be dispensed with.
- 4. That procurement of these goods does not fall under the prohibition on "Splitting of Government Contracts."
- 5. The winning bidder was verified, validated, and ascertained that it is not included in any government "blacklist."
- 6. The use of other means for verification and validation, such as the Internet and other research methods, of the bidder's documents, was resorted to by the BAC/TWG.
- 7. The BAC/TWG tested samples for compliance with specifications and performance levels, as well as aftersales and/or maintenance capabilities, where applicable.
- 8. KSU has ensured that the contract's objectives and purpose do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure.

**NOW, THEREFORE**, we, the Members of the BAC, hereby **RESOLVE AS IT HEREBY RESOLVED**: to declare the concerned bidder, indicated at the Abstract of Sealed Quotation, as post qualified, and to recommend for approval by the KSU President of an award.

  - Section 35.1(c), 2016 R-IRR of RA 9184: **All bids failed to post qualify.**
  - Section 35.1(d), 2016 R-IRR of RA 9184: **Someone post qualified but refused without justifiable cause to accept the award.**
- SUBJECT FOR RE-BID** based on the following:
- Section 35.2, 2016 R-IRR of RA 9184: **Task the BAC and TWG to conduct mandatory review and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents.**
  - Section 35.3, 2016 R-IRR of RA 9184: **To task the BAC to conduct a re-bidding with re-advertisement and/or posting.**
  - Section 35.5, 2016 R-IRR of RA 9184: **To resort to negotiated procurement, specifically Two Failed Biddings (Sec. 53.1).**
