A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT

**BAC Resolution No. 076
 Series of 2021**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** re-published the Invitation to Bid in the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) on February 17-25, 2021, for the re-bidding of **Construction of KSU-Rizal Campus Covered Court** with an Approved Budget for the Contract (ABC) amounting to **One Million, Four Hundred Fifty-Five Thousand, One Hundred Seventy-Six Philippine Pesos (Php 1,455,176.00)** sourced from Internally Generated Income Fund for CY 2020 and posted the same at the KSU Website (<https://ksu.edu.ph/>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days, after its first failed bidding conducted for the period: January 15, 2021 to February 8, 2021;

WHEREAS, in response to the said posting/advertisement, **nine (9) prospective bidders**, namely: Lucky Gems Construction, Construction Bros, Willen Builders, Polo Engineering and Construction, Hillstone Builders, Four-G Construction, HKBT Construction, EEJ Construction, and WIMREG Construction and Supply, browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-bid Conference** simultaneously via Google Meet Link: meet.google.com/mqj-boza-goz with the bidder's representatives on **February 26, 2021 @ 10 am** whereupon **Supplemental Bid/Bulletins (SBB) No. 01** dated March 1, 2021 was issued to amend the contents of bidding documents particularly on the technical requirements of the project;

WHEREAS six (6) bidders, namely: Willen Builders, Hillstone Builders, Four-G Construction, HKBT Construction, EEJ Construction, and WIMREG Construction and Supply, have purchased the bidding documents on February 26, 2021, March 1-4, 2021, respectively;

WHEREAS, during the **Receipt and Opening of Bids on March 10, 2021 @ 10 am**, said 6 bidders who purchased the bid documents submitted their bid envelopes containing the technical and financial documents before the scheduled time;

WHEREAS during the **Opening of Bids**, the BAC, upon the recommendation of the TWG-Infra, declared the bid of EEJ Construction as "ineligible" while the other 5 bidders were declared as "**eligible**" and passed the technical evaluation of the bidding;

WHEREAS the TWG recommended to the BAC, upon opening the Financial Bid Envelopes, to declare the bids of said 5 eligible bidders as "**complying**", and declared further the bid of WIMREG Construction and Supply in the amount of One Million, Two Hundred Seventy-Seven Thousand, Six Hundred Six Philippine Pesos and Twenty-Six Centavos (Php 1,277,606.26) as the **lowest calculated bid** and the bids as calculated are as follows:

WHEREAS on March 15, 2021, the BAC did not receive any MR from EEJ Construction;

WHEREAS, the TWG-Infra, upon the conduct of post-qualification evaluation by the Post Qual Team on March 17, 2021 recommended to the BAC to declare the bid of WIMREG Construction and Supply as the **Lowest Calculated and Responsive Bid (LCRB)**;

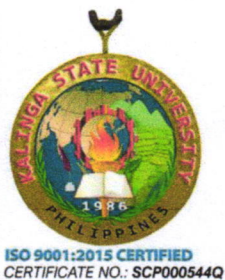
WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, **hereby recommends for approval by the University President to declare the bid of WIMREG Construction and Supply as Lowest Calculated Responsive Bid and to award the contract amounting to One Million, Two Hundred Seventy-Seven Thousand, Six Hundred Six Philippine Pesos and Twenty-Six Centavos (Php 1,277,606.26) for the Construction of KSU-Rizal Campus Covered Court.**

RESOLVED FINALLY to post this Resolution at the PhilGEPS and KSU Websites and conspicuous place at the University's premises, including the BAC Bulletin Board, for transparency and information purposes.

Action of HOPE on BAC Recommendation through BAC Resolution No. 076, Series of 2021

By the power vested in me by the Kalinga State University Board of Regents, I hereby:

- APPROVE** the attached Resolution of the BAC based on the foregoing:
- Section 34.4, 2016 R-IRR of RA 9184: **Lowest Calculated and Responsive Bid (LCRB) or Highest Rated and Responsive Bid (HRRB).**
 - Section 36, 2016 R-IRR of RA 9184: **Single Calculated and Responsive Bid (SCRB) or Single Rated and Responsive Bid (SRRB).**

 - Section 35.1(c), 2016 R-IRR of RA 9184: **All bids failed to post qualify.**
 - Section 35.1(d), 2016 R-IRR of RA 9184: **Someone post qualified but refused without justifiable cause to accept the award.**
- SUBJECT FOR RE-BID** based on the following:
- Section 35.2, 2016 R-IRR of RA 9184: **Task the BAC and TWG to conduct mandatory review** and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents.
 - Section 35.3, 2016 R-IRR of RA 9184: **To task the BAC to conduct a re-bidding with re-advertisement and/or posting.**
 - Section 35.5, 2016 R-IRR of RA 9184: **To resort to negotiated procurement, specifically Two Failed Biddings (Sec. 53.1).**
