



A BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND AND RECOMMENDING FOR AWARD OF CONTRACT

BAC Resolution No. 346 Series of 2020

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the **Invitation to Bid** in the PhilGEPS Website temporary facility: <http://notices.ps-philgeps.gov.ph> on **September 14-22, 2020**, for the conduct of public bidding on the **Upgrading of Button Mushroom Facility at Kalinga State University** with a total Approved Budget for the Contract (ABC) amounting to **Five Million, Four Hundred Six Thousand, One Hundred Ninety-Two Philippine Pesos and Thirty-Seven Centavos (Php 5,406,192.37)** sourced from **Trust Receipt Fund CY 2020** and posted the same at the KSU Website (<https://ksu.edu.ph/bid/upgrading-button-mushroom-facility-kalinga-state-university>), and conspicuous place at the premises of the University Campuses, continuously for **seven (7)** calendar days;

WHEREAS, in response to the said **posting/advertisement**, **three (3) prospective bidders**, namely: **First Reliable Builders, A.L. Sagandoy Construction, and Renton Engineering Services**, browsed/read the opportunity at the sites mentioned above, and the last two bidders availed of the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Groups for Infrastructure Projects conducted the **online Pre-bid Conference** via Google Meet link: meet.google.com/umq-vcuz-fio with the bidder's representatives on **September 23, 2020 @ 10:00 am** whereupon **Supplemental Bid/Bulletin (SBB) No. 01 dated September 26, 2020** was issued to amend the contents of bidding documents;

WHEREAS, during the **submission and receipt of bids on October 5, 2020 at 10 am, A.L. Sagandoy Construction and Renton Engineering Services** have submitted their bid envelopes;

WHEREAS, during the **Opening of Bids** on the same day- **October 5, 2020 at 10 am @ 10:01 am**, the **technical document of A.L. Sagandoy Construction** was rated "**ineligible**" while **Renton Engineering Services** was declared "**eligible**" and passed the technical evaluation of the bidding;

WHEREAS, the TWGs recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of **Renton Engineering Services** in the amount of **Four Million, Eight Hundred Fifty-Nine Thousand, One Hundred Twenty-Eight Philippine Pesos and Fifty-Nine Centavos (Php 4,859,128.59)** as the bidder with Single Calculated Bid subject to the conduct of post-qualification evaluation;

WHEREAS, on the next day- **October 6, 2020**, the TWG started conducting their Arithmetic Bid Evaluation on the proposals of **Renton Engineering Services** before scheduling the post-qualification evaluation;

WHEREAS, the TWG together with other Post Qual Team Members, upon the conduct of **online post-qualification evaluation** via Google Meet link: meet.google.com/kpr-zbhd-cde on **October 21, 2020 (Wednesday) at 1 pm** recommended to the BAC to declare the bid of **Renton Engineering Services** as the **Single Calculated Responsive Bid (SCRB)**;

Action of HOPE on BAC Resolution No. 346, Series of 2020 on Post Qualification Findings

By the power vested in me by the Kalinga State University Board of Regents, I hereby:

- APPROVE** the attached Resolution of the BAC based on the foregoing:
- Section 34.4, 2016 R-IRR of RA 9184: Lowest Calculated and Responsive Bid (LCRB) or Highest Rated and Responsive Bid (HRRB).*

 - Section 35.1(b), 2016 R-IRR of RA 9184: Bids received but no one was eligible.*
 - Section 35.1(c), 2016 R-IRR of RA 9184: All bids failed to post qualify.*
 - Section 35.1(d), 2016 R-IRR of RA 9184: Someone post qualified but refused without justifiable cause to accept the award..*
- SUBJECT FOR RE-BID** based on the following:
- Section 35.2, 2016 R-IRR of RA 9184: Task the BAC and TWG to conduct mandatory review and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents.*
 - Section 35.3, 2016 R-IRR of RA 9184: To task the BAC to conduct a re-bidding with re-advertisement and/or posting.*
 - Section 35.5, 2016 R-IRR of RA 9184: To resort to negotiated procurement, specifically Two Failed Biddings (Sec. 53.1).*
