

## INVITATION TO BID FOR PROCUREMENT OF VARIOUS LABORATORY EQUIPMENT INCLUDING FURNITURE AND FIXTURES

- The Kalinga State University, through the Internally Generated Income Fund for CY 2020, intends to apply the sum of Seven Million Six Hundred Ninety-One Thousand Eight Hundred Philippine Pesos (Php 7,691,800.00) being the total ABC to payments under the contract for Procurement of Various Laboratory Equipment including Furniture and Fixtures/IB\_Goods\_2020-12-079 for the following lots. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

Partial bids are allowed. All Goods are grouped into lots listed below. Bidders shall have the option of submitting a proposal on any or all lots, and evaluation and contract award will be undertaken on a per-lot basis. Lots shall not be divided further into sub-lots for the purpose of bidding, evaluation, and contract award.

- The Kalinga State University now invites bids for the above Procurement Project. Delivery of the Goods is required by **Delivery Schedules indicated for each lot above and upon receipt of the Purchase Order**. Bidders should have completed, within **four (4) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- Prospective Bidders may obtain further information from **Kalinga State University** and inspect the Bidding Documents at the address given below during **office hours from 8 am to 5 pm**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **December 24, 2020 (Thursday) until 9 am of January 19, 2021 (Tuesday)** from the given address and websites below, *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount and schedule indicated above but not to exceed the maximum amount of Ten Thousand Philippine Pesos (Php 10,000.00) as prescribed in the Guidelines for the sum of the ABC of all lots*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *either in person or through electronic means*.
- The Kalinga State University will hold a **Pre-Bid Conference** on **January 7, 2021 (Thursday), 10 am** at the **BAC Conference Room, Procurement Management Office, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga**, and/or through video conferencing or webcasting via **Google Meet Platform** at the link: [meet.google.com/moj-jrys-oyh](https://meet.google.com/moj-jrys-oyh), which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below, on or before **10 am on January 19, 2021 (Tuesday)**. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

The **Kalinga State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
