<p>Based on the Discussion during the Pre-bid Conference conducted on June 19, 2020, @ 10:00 am for this Project, the following are the revisions:</p> <p>1. On Paragraph 1 of the Invitation to Bid, Section I, and page 4 of the bid document, below is the revision:</p> <p>... Bidders shall have the one option of submitting a proposal on a lot or all the two lots. If the bidder opts to bid for more than one lot, only one set of eligibility requirements shall be submitted. Evaluation and award of contract will be undertaken per lot basis; however, for a bidder that bids to more than one lot and determined to have the Lowest Calculated Responsive Bid should be awarded only one contract...</p>										
<p>2. On ITB Clause 5.4(b) of the Bid Data Sheet under Section 3, page 30 of the bid document, the following is the new clause:</p> <p>For this purpose, similar contracts shall refer to contracts, i.e., Construction of One-Storey Building or Construction of Motor Pool Building, which has the similar major categories of work of equivalent size, equivalent to at least fifty percent (50%) of the total ABC, which is Php 7,281,554.00.</p>
