## SUPPLEMENTAL/BID BULLETIN (SBB) ADDENDUM NO. 01

Based on the Discussion during the Pre-bid Conference conducted on September 23, 2020, @ 10:00 am for this Project, the following are the revisions (texts highlighted in red color are the items to be revised, while those in yellow color are the amendments).

- **A. AMENDMENTS ON APPROVED BUDGET FOR THE CONTRACT (ABC).** The following revisions on ABC are based on the approved programming concurred by DPWH.
  - a) 1st Paragraph of the Invitation to Bid, Section I, page 4 of the bidding document
    - 1. The Kalinga State University (KSU), through the Trust Receipt Fund CY 2020 intends to apply the sum of Five Million, Four Hundred Six Thousand, One Hundred Ninety-Two Philippine Pesos and Thirty-Seven Centavos (Php 5,406,192.37) Four Million, Eight Hundred Seventy-Five Thousand, Eight Hundred Thirty-Two Philippine Pesos (Php 4,875,832.00) being the Approved Budget for the Contract (ABC) to payments under the Contract for Upgrading of Button Mushroom Facility at Kalinga State University/ IB\_CivilWorks\_2020-09-048. Bids received in excess of the ABC shall be automatically rejected at bid opening.

**Partial bids are NOT allowed.** Prospective bidders shall have one option of submitting a proposal for these 2 categories, and evaluation and contract award will be undertaken as one lot basis.

C. ON THE AMOUNT BIDDING DOCUMENT. <u>Paragraph No. 5 of the Invitation to Bid, Section I, page 4 of the bidding document</u>, the amount of bidding document shall be decreased as per the Standard Rates on the Sale of Bidding Documents, as follows:

5. Interested bidders may acquire a complete set of Bidding Documents on **September 14, 2020 (Monday) until 10:00 am of October 5, 2020 (Monday)** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Philippine Pesos (Php 10,000.00) Five Thousand Philippine Pesos (Php 5,000.00).* 

D. COMPUTATION OF 50% OF THE ABC FOR SLCC. On ITB Clause 5.4 of the Bid Data Sheet, Section III, page 30 of the bidding document, the ABC's computation shall be based on the Construction component and due to changes in the ABC, the following is the corrected reference.

For this purpose, similar contracts shall **refer to contracts, i.e., Construction of One-Storey Building or Construction of Agricultural Building, which has the similar major categories of work of equivalent size,** equivalent to at least fifty percent (50%) of the total ABC, which is **Php** 1,897,611.00 1,899,482.50.
