## A BAC RESOLUTION DECLARING FAILURE OF BIDDING AND FOR RE-BIDDING

## **RESOLUTION NO. 462, S. 2017** (GOODS)

**WHEREAS,** in compliance with the provisions of RA 9184, the Kalinga State University advertised in the PhilGEPS website, KSU website, BAC Bulletin Board, and conspicuous place at the premises of the University the Invitation to Bid for the hereunder Purchase Request continuously from March 23, 2017 to April 12, 2017:

**WHEREAS**, in response to the said advertisement, there were eight (8) suppliers who ordered or downloaded the bidding documents through the PhilGEPS Document Request List including Digital Software Technology Consultancy who bought a set of bidding documents last April 7, 2017;

**WHEREAS**, during the Receipt and Opening of Bids on April 12, 2017, no bidders have dropped their bids prompting the BAC to declare a failure of bidding;

**WHEREAS**, as per report of the BAC Secretariat and TWG, there were suppliers who made inquiries and request as to detailed specifications and additional funding of the project;

**NOW, THEREFORE,** We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:** 

to declare a failure of bidding due to absence of bids receipt as provided by Section 35.1(a) of the 2016 IRR of R.A. 9184 for the Procurement and Installation of Online Enrolment System with Accounting System;

to task the TWG for mandatory review and evaluation of the technical specifications, terms, conditions, scope of work, cost estimates, and if necessary, adjust the ABC, subject to applicable threshold and required approvals by authorities, to suit the actual conditions of the project; and

to recommend for approval by the President of the Kalinga State University for the re-bidding with re-advertisement of this project upon compliance of the above tasking.
