



A BAC RESOLUTION DECLARING A FAILURE OF BIDDING AND RECOMMENDING FOR RE-BIDDING

BAC Resolution No. 148 Series of 2019

WHEREAS, in compliance with the provisions of RA 9184 and its Implementing Rules and Regulations (IRR), the **Kalinga State University (KSU)** published in the PhilGEPs website (<https://www.philgeps.gov.ph>) on **February 23, 2019 to March 5, 2019** the **Invitation to Bid** for the conduct of public bidding on the **"Upgrading of 3-Phase Line Distribution Power System of KSU Bulanao Campus- Phase I"** with an Approved Budget for the Contract (ABC) amounting to **One Million, Nine Hundred Forty-Five Thousand, Five Hundred Forty-Nine Philippines Pesos (Php 1,945,549.00)** and posted the same at the KSU website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses, continuously for **seven (7)** calendar days;

WHEREAS, in response to the said **posting/advertisement**, **two (2) prospective bidders**, namely: **LMPR Electrical Supplies and Services**, and **WWW.Construction** browsed/read the opportunity at the above-mentioned posting sites and **both bidders availed the bidding documents**;

WHEREAS, the **Bids and Awards Committee (BAC)** and the **Technical Working Group for Infrastructure Projects (TWG-Infra)** conducted the **Pre-bid Conference** with the bidder's representatives of **WWW.Construction** on **March 6, 2019 @ 10 am** whereupon no **Supplemental Bid/Bulletin** was issued to amend or clarify the content of bid documents;

WHEREAS, during the **Receipt/Submission of Bids** on **March 18, 2019 @ 10 am**, both **LMPR Electrical Supplies and Services**, and **WWW.Construction** submitted their proposals containing the Eligibility and Technical Components (1st envelope) and Financial Component (2nd envelope);

WHEREAS, during the **Opening and Evaluation of Bids** on **March 18, 2019 @ 10:01 am**, the **BAC declared**, upon recommendation of the TWG-Infra, the bid of **LMPR Electrical Supplies and Services** as **"ineligible"** for **failing to meet the requirement on Single Largest Completed Contract (SLCC)** and the bidder's representatives expressed their intent to file a Motion for Reconsideration (MR) upon confirming with their principal;

WHEREAS, during the **Opening and Evaluation of Bids** of **WWW.Construction**, the TWG recommended to the BAC to **declare the Statement of the concerned bidder's Ongoing Government and Private Contracts** as **"ineligible"** and the bidder's representatives expressed also their intent to file an MR;

WHEREAS, on **March 20, 2019**, both **LMPR Electrical Supplies and Services**, and **WWW.Construction** submitted their respective MR's whereupon the BAC convened on **March 25, 2019 @ 3 pm** and resolved to **deny both the bidders' MR's** due to lack of merit;

WHEREAS, the **BAC Secretariat** issued on **March 28, 2019** the **Notice of BAC Resolution** denying the requests for reconsideration of **LMPR Electrical Supplies and Services** and **WWW.Construction**;

WHEREAS, on **April 5, 2019**, the BAC Secretariat informed the BAC that the Office of the President did not receive any protest from concerned bidders within the seven (7) day filing period;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, hereby declare a failure of bidding due to ineligibility of two (2) prospective bidders namely: LMPR Electrical Supplies and Services, and WWW.Construction to pass the technical evaluation of the bidding, pursuant to Section 35.1.b of the IRR of RA No. 9184; and to recommend for approval by the University President of the conduct of another bidding for the Upgrading of 3-Phase Line Distribution Power System of KSU Bulanao Campus- Phase I.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
