

## A BAC RESOLUTION DECLARING TWO FAILED BIDDINGS AND **RECOMMENDING FOR A NEGOTIATED PROCUREMENT**

**RESOLUTION NO. 451, SERIES OF 2018** 

(CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) re-posted in the PhilGEPS website (https://www.philgeps.gov.ph) on August 8-28, 2018 the Invitation to Bid (IB) for the conduct of public bidding for Package Contract for Improvement of KSU Main Gate with an Approved Budget for the Contract (ABC) amounting to One Million, Six Hundred Fifty-One Thousand, Eight Hundred Ten Philippines Pesos and Sixty-Two Centavos (Php1,651,810.62) and posted the same at the KSU website (http://ksu.edu.ph), and conspicuous place at the premises of the University Campuses, continuously for seven days, after its first failed bidding conducted on May 8-28, 2018;

WHEREAS, in response to the said advertisement, two (2) prospective bidders browsed/read the posting opportunity at the PhilGEPS Website, KSU Website and Bulletin Boards, namely: (1) CNG Construction, and (2) Hillstone Builders who availed the bidding documents;

WHEREAS, the BAC and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-Bid Conference with the prospective bidder (only CNG Construction's representative has attended) on August 16, 2018 @ 1 PM whereupon Supplemental Bid Bulletin (SBB) No. 1 dated August 16, 2018 was issued regarding amendments and clarifications in the contents of bid documents particularly on Instructions to Bidders, Bid Data Sheet, and Specifications containing the Terms of Reference and Scope of Works;

WHEREAS, during the Receipt and Opening of Bids on August 28, 2018 at 1 PM, no bidders have submitted their bids that prompted the BAC to declare a 2nd failure of bidding;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, hereby declare second failure of biddings for the Package Contract for Improvement of KSU Main Gate due to non-receipt of bids pursuant to Section 35.1(a) of the 2016 IRR of RA 9184; and to recommend for approval by the Head of Procuring Entity to resort into a Negotiated Procurement under Two-Failed Biddings modality as provided by Section 53.1 of the 2016 IRR of RA 9184.

**RESOLVED FINALLY,** to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
