



**A BAC RESOLUTION DECLARING MANINDRA AUTO CORPORATION AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT**

**RESOLUTION NO. 732, S. 2017**  
 (GOODS)

**WHEREAS**, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) posted in the PhilGEPS website (<https://www.philgeps.gov.ph>) on December 9, 2017 a Notice of Negotiated Procurement for **Purchase of One Unit Service Utility Vehicle (Ref. No. 264004080300003)** with an Approved Budget for the Contract (ABC) amounting to **One Million Five Hundred Thousand Philippine Pesos (Php 1,500,000.00)** and posted the same at the KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University continuously for three (3) calendar days after approval by the University President on December 8, 2017 of a BAC resolution recommending for a Negotiated Procurement following the conduct of two failed biddings for the period: October 22, 2017 to November 15, 2017 and November 16, 2017 to December 6, 2017;

**WHEREAS**, in response to the said posting/advertisement, one (1) bidder: FDG Consulting browsed/read the opportunity at the PhilGEPS and KSU websites, while three (3) bidders: Manindra Auto Corporation, Elite North Auto Cars Incorporated, and Nissan Baliwag read the notice at the BAC Bulletin Board;

**WHEREAS**, during the **Receipt of Bids on December 12, 2017**, Manindra Auto Corporation submitted its bid envelope while Elite North Auto Cars Incorporated and Nissan Baliwag submitted only the filled-out Notice of Negotiated Procurement without the supporting documents;

**WHEREAS**, during the **Evaluation of Bids**, Manindra Auto Corporation was declared "eligible" by the Bids and Awards Committee (BAC) and passed the technical evaluation of the bidding while the other two bidders were declared ineligible due to above-the-ABC offers and lack of documents;

**WHEREAS**, the Technical Working Group for Goods (TWG-Goods) recommended to the BAC, upon opening the financial bid envelope, to declare the bid of **Manindra Auto Corporation** in the amount of **One Million, Four Hundred Eighty Thousand Philippines Pesos (Php1,480,000.00) as the Lowest Calculated Bid (LCB) as Read** subject to the conduct of post qualification evaluation;

**WHEREAS**, the TWG-Goods, upon conduct of post qualification evaluation by its composite members on December 20, 2017 recommended to the BAC, **to declare the bid of Manindra Auto Corporation as the Lowest Calculated and Responsive Bid (LCRB);**

**NOW, THEREFORE**, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**

**to declare the bid of Manindra Auto Corporation as the Lowest Calculated and Responsive Bid based on the recommendation of Technical Working Group for Goods (Vehicle); and**

**to recommend for approval by the Head of the Procuring Entity of the Kalinga State University the award of contract amounting to One Million, Four Hundred Eighty Thousand Philippines Pesos (Php1,480,000.00) to Manindra Auto Corporation for Negotiated Procurement for Purchase of Service Utility Vehicle.**

**RESOLVED FINALLY**, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.




