A BAC RESOLUTION DECLARING MALABONG CONSTRUCTION SUPPLY AND GENERAL MERCHANDISE AND TNJ BUILDERS AS POST OUALIFIED AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 734, S. 2017

(GOODS AND CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University published in the PhilGEPS website on February 9, 2017 to March 1, 2017 (first bidding), and March 4-27, 2017 (second bidding) the Invitation to Bid for the conduct of public bidding for Construction of Potable Water Systems at Bulanao Campus with an Approved Budget amounting to (Php 2,912,621.00) and posted the same at the KSU website (http://ksu.edu.ph), and conspicuous place at the premises of the University continuously for seven days which were failed due to absence of participating bidders;

WHEREAS, after the two failed biddings, the TWG and Infrastructure Unit requested the DPWH Kalinga for the use of their water drilling equipment and the latter responded that KSU should wait for their turn in the usage of the equipment;

WHEREAS, upon recommendation of the TWG, the BAC published on November 26, 2017 to December 5, 2017 the Invitation to Bid for the Purchase of Hardware Materials for Construction of Two Units Potable Water System at Bulanao Campus whereupon neither bidders availed the bid documents nor attended the Pre-bid Conference on December 6, 2017;

WHEREAS, during the Receipt and Opening of Bids on December 18, 2017, no bidders have submitted their bids and the BAC declared another failed bidding, resolved to negotiate the Lot1: Purchase of Hardware Materials for the drilling of water system with an ABC of Php1,549,956.22 and the Lot 2: Construction of Concrete Water Tank- Php1,288,755.18 through Two-Failed Biddings Alternative Mode of Procurement (in line with earlier BAC Resolution No. 292, Series of 2017 dated March 31, 2017) and posted the opportunity at PhilGEPS, KSU websites and conspicuous places at the premises of the University for the period: December 27-30, 2017;

WHEREAS, in response to the Notice for Negotiated Procurement, Malabong Construction Supply and General Merchandise submitted its bid for the Lot 1 or goods component of the project while TNJ Builders submitted its bid for the Lot 2 civil work component that were opened at 10:01am on December 30, 2017;

WHEREAS, on the same day, the BAC declared the bids of both bidders as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the BAC, upon opening the financial bid envelope, declared the bid of Malabong Construction Supply and General Merchandise for Project Lot 1 in the amount of Php1,539,355.79, and the bid of TNJ Builders for Project Lot 2 amounting to PhP1,269,754.32 as the Single Calculated Bid (SCB) As Read subject to the conduct of post qualification evaluation;

WHEREAS, as part of Post Qualification process and considering the time element for this project, the BAC verified the satisfactory accomplishments and historical transactions of both bidders with the University and other entities and declared them as "responsive" bidders;

to declare the bid of Malabong Construction Supply and General Merchandise and TNJ Builders both as Single Calculated and Responsive Bids, based on the evaluation process conducted; and

to recommend for approval by the Head of the Procuring Entity of the Kalinga State University the award of contract amounting to ONE MILLION FIVE HUNDRED THIRTY-NINE THOUSAND THREE HUNDRED FIFTY-FIVE PHILIPPINE PESOS AND SEVENTY-NINE CENTAVOS (PhP1,539,355.79) to Malabong Construction Supply and General Merchandise for Project Lot1: Purchase of Hardware Materials, and ONE MILLION TWO HUNDRED SIXTY-NINE THOUSAND SEVEN HUNDRED FIFTY-FOUR PHILIPPINE PESOS AND THIRTY-TWO CENTAVOS (PhP1,269,754.32) to TNJ Builders for the Project Lot 2: Construction of Concrete Water Tank for the Negotiated Procurement for Construction of Potable Water System at Bulanao Campus.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
