



A BAC RESOLUTION DECLARING A FAILURE OF BIDDING AND RECOMMENDING FOR A RE-BIDDING

RESOLUTION NO. 755, SERIES OF 2018 (CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the **Kalinga State University (KSU)** posted in the PhilGEPS website (<https://www.philgeps.gov.ph>) on November 8-15, 2018 the Invitation to Bid (IB) for the conduct of public bidding for **Completion of Graduate Studies and Law Building** with an Approved Budget for the Contract (ABC) amounting to **Seven Million, Seven Hundred Seventy-Five Thousand, One Hundred Nineteen Philippines Pesos (Php 7,775,119.00)** and posted the same at the KSU website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses, continuously for seven (7) days;

WHEREAS, in response to the said **advertisement**, seven (7) prospective bidders namely: I.P. Lacwasan Construction and Development Corporation, GNF General Merchandise, Matagoan KJ Builders and Engineering Services, CNG Construction, MCPC Builders and Developers, Trinity Construction and Development, and Hillstone Builders have browsed/read the posting opportunity at the **PhilGEPS Website, KSU Website and Bulletin Boards**;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-Bid Conference** with the bidders' representatives on **November 16, 2018** whereupon **Supplemental Bid/Bulletin (SBB) No. 01 dated November 23, 2018, SBB No. 02- Nov 25, 2018, and SBB No. 03- Nov 26, 2018** were issued regarding amendments and clarifications in the bidding documents particularly the scope of works, and postponement of bid submission from November 28, 2018 to December 3, 2018 @ 10 am due to non-availability of projects' blueprint/drawing and to give ample time for prospective bidders to prepare their proposals;

WHEREAS, during the **Receipt and Opening of Bids on December 3, 2018 @ 10 AM**, MCPC Builders and Developers that availed the bid documents has submitted its bids whereupon the BAC rated its Technical Documents particularly on Single Largest Completed Contract (SLCC) as **"ineligible"** and the bidder's representative waived their right to file a motion for reconsideration;

WHEREAS, the TWG-Infra recommended to the BAC, upon receipt of the waiver to re-publish for the second time this project;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, hereby declare a failure of bidding pursuant to Section 35.1(b) of the 2016 IRR of RA No. 9184 and recommending for approval by the University President of a re-bidding with re-advertisement of the Invitation to Bid.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
