

A BAC RESOLUTION DECLARING TWO FAILED BIDDINGS AND RECOMMENDING FOR A NEGOTIATED PROCUREMENT

RESOLUTION NO. 756, SERIES OF 2018 (CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184 and its Implementing Rules and Regulations (IRR), the Kalinga State University (KSU) re-posted in the PhilGEPS website (https://www.philgeps.gov.ph) on December 8-16, 2018 the Invitation to Bid (IB) for re-conduct of public bidding for Completion of Graduate Studies and Law Building with an Approved Budget for the Contract (ABC) amounting to Seven Million, Seven Hundred Seventy-Five Thousand, One Hundred Nineteen Philippines Pesos (Php 7,775,119.00) and posted the same at the KSU website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) days after its first failure of bidding conducted for the period: November 8, 2018 to December 3, 2018;

WHEREAS, in response to the said **advertisement**, three (3) prospective bidders namely: Nine Eleven Diner, GNF General Merchandise, and Power A Construction have browsed/read the posting opportunity at the **PhilGEPS Website**, KSU Website and Bulletin Boards;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-Bid Conference** with no bidder's representatives in attendance on **December 17, 2018 @ 1pm whereupon Supplemental Bid/Bulletin (SBB) No. 01 dated December 20, 2018** was issued regarding amendments and clarifications in the bidding documents particularly the scope of works;

WHEREAS, during the Receipt and Opening of Bids on December 28, 2018 @ 10 AM, neither bidders avail nor submit their proposals which prompted the BAC, through the recommendation of the TWG-Infra, to declare another failure of bidding due to non-receipt of bids;

WHEREAS, the TWG-Infra recommended to the BAC to allow the sub-contracting of the Elevator System, Item No. 1203 of the Bill of Quantities and Scope of Works in proviso that main contractor will be responsible for the acts, defaults, and negligence of the subcontractor, its agents, servants, or workers, in consideration that most bidders in the locality have no experienced on elevator works or construction;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, hereby declare another failed bidding pursuant to Section 35.1(a) of the 2016 IRR of RA No. 9184; to recommend for approval by the University President of the conduct of Negotiated Procurement through Two-Failed Bidding (Section 53.1-IRR of RA No. 9184) modality following the procedures on Annex "H" or the Consolidated Guidelines for the Alternative Methods of Procurement of the IRR of RA No. 9184; and recommending further that Elevator System- Item No. 1203 of the Bill of Quantities and Scope of Works be sub-contracted as part of the mandatory review.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
