A BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING FOR A RE-BIDDING

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) posted in the PhilGEPS website (https://www.philgeps.gov.ph) on December 19, 2018 to January 8, 2019 the Invitation to Bid (IB) for the conduct of public bidding for the Project: Procurement of ICT Equipment with Peripherals, Installation, Configuration and Training with an Approved Budget for the Contract (ABC) amounting to Ten Million Philippines Pesos (Php 10,000,000.00) and posted the same at the KSU website (https://ksu.edu.ph), and conspicuous place at the premises of University Campuses, continuously for seven (7) days;

WHEREAS, in response to the said advertisement/posting, there are six (6) prospective external service providers who browsed/read the bidding documents posted at the required sites, namely: A.S. Online Consulting Incorporated, Xitrix Computer Corporation, GNF General Merchandise, Roughclaw Enterprises, Philcomp Enterprises, and Electronic Information Solutions Incorporated;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Groups (TWGs) for Goods related Supplies and Materials and IT related Supplies and Equipment conducted the **Pre-Bid Conference on December 27, 2018 @ 10am** whereupon no prospective bidders have attended but a Supplemental Bid No. 01 dated December 27, 2018 was issued regarding amendments and clarifications in the bid documents;

WHEREAS, during the **Receipt and Opening of Bids on January 8, 2019** @ 10am, no bidders have submitted their proposals which prompted the BAC to declare a failure of bidding and the TWG to recommend for its re-bidding subject for mandatory review of the terms and conditions;

WHEREFORE, the Bids and Awards Committee, exercising prudence, good faith and transparency, and upon recommendation of the Technical Working Groups for Goods-related Supplies and Materials and IT-related Supplies and Equipment, hereby RESOLVE AS IT IS HEREBY RESOLVED:

to declare a failure of bidding for the Procurement of ICT Equipment with Peripherals, Installation, Configuration and Training due to non-receipt of bids pursuant to Section 35.1(a) of the 2016 IRR of RA 9184, and

to recommend for a conduct of re-bidding with re-advertisement on proviso that TWGs shall revise, if applicable, the technical, legal and financial eligibility requirements including technical specifications.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
