



A BAC RESOLUTION DECLARING SCRB AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 270, S. 2017 (INFRA)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) published in the Manila Bulletin on May 2, 2017 the Invitation to Bid (IB) for the conduct of public bidding for the Construction of 4-Storey Academic Building in Bulanao (Initial Phase) with an Approved Budget for the Contract (ABC) amounting to Fifteen Million, Five Hundred Nineteen Thousand, Eighty Philippine Pesos and Fifty-four Centavos (Php 15,519,080.54) and posted the same at the PhilGEPS website (<https://www.philgeps.gov.ph>), KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University continuously for seven days;

WHEREAS, in response to the said advertisement, there were two (2) bidders, namely: GNF General Merchandise and CNG Construction who browsed/downloaded the bid documents through the Document Request List (DRL) of the PhilGEPS website on May 2 & 10, 2017, while Alcel Construction has purchased said documents on May 17, 2017;

WHEREAS, the Bids and Awards Committee and the Technical Working Group for Infrastructure Projects conducted a Pre-bid Conference with the prospective bidders on May 10, 2017 whereupon Supplemental Bid Bulletin No. 1 dated May 15, 2017 was issued regarding amendments and clarifications in the bid documents;

WHEREAS, during the Receipt and Opening of Bids on May 22, 2017 at 10 A.M., only Alcel Construction submitted its bid, was evaluated by the BAC and TWG, was declared as the Single Lowest Calculated Bidder - subject for post qualification, and the bid as read is as follows:

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED**:

to declare Alcel Construction as post qualified, being the bidder with Single Calculated and Responsive Bid (SCRB) in the Total Amount of Fifteen Million, Four Hundred Thirty-six Thousand, Four Hundred Sixty Philippine Pesos and Seventy-five Centavos (Php15,436,460.75) for Construction of 4-Storey Academic Building in Bulanao (Initial Phase); and

to recommend for approval by the President of the Kalinga State University of an award and the foregoing findings.








