



**A BAC RESOLUTION DECLARING SCRB AND RECOMMENDING AWARD OF CONTRACT**

**RESOLUTION NO. 317, S. 2017**  
**(GOODS)**

**WHEREAS**, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) published in the PhilGEPS website (<https://www.philgeps.gov.ph>) on May 13, 2017 to June 5, 2017 the Invitation to Bid (IB) for the conduct of public re-bidding for **Purchase of IT Equipment and Furniture for eLibrary Modernization (Ref. No. IGF05-2017-05-0339) with 2 lots namely: Lot 1: Furniture for eLibrary/ ABC is Php 996,300.00, and Lot 2: Computer System Units, Network Devices and Peripherals/ ABC is Php 975,705.00 and with total Approved Budget for the Contract (ABC) amounting to One Million, Nine Hundred Seventy-two Thousand, Five Philippine Pesos (Php 1,972,005.00)** and posted the same at the KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University continuously for seven days, following a failure of bidding conducted for the period: March 10, 2017 to April 3, 2017;

**WHEREAS**, the Bids and Awards Committee and the Technical Working Group for Information and Technology (IT) conducted a Pre-bid Conference on May 24, 2017 with neither attendance from prospective bidders nor Supplemental Bid/Bulletin issued regarding amendments and clarifications in the bid documents;

**WHEREAS**, during the Receipt and Opening of Bids on June 5, 2017 at 10 A.M., only GNF General Merchandise submitted its bid for the Lot 1: Furniture for eLibrary, was evaluated by the BAC and TWG, was declared as the Single Lowest Calculated Bidder - subject for post qualification, and the bid as read is as follows:

**WHEREAS**, through Resolution No. 235, Series of 2017 dated June 6, 2017, the BAC declared a partial failure of bidding on Lot 2: Computer System Units, Network Devices and Peripherals component of the project due to non-receipt of bids pursuant to Section 35.1(a) of the 2016 Revised IRR of RA 9184 and recommended to the HOPE for negotiated procurement;

**WHEREAS**, on June 8, 2017, the BAC found out a discrepancy on the quantity of the bid of GNF General Merchandise and asked clarifications to the bidder on June 13, 2017 which the latter accepted to deliver said non-accounted items;

**WHEREAS**, the TWG for IT Projects and its designated staff, upon conduct of post qualification evaluation for the period- June 22, 2017, recommended to the BAC to declare the bid of GNF General Merchandise as "responsive;"



**NOW, THEREFORE,** We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**


*to declare GNF General Merchandise as post qualified, being the bidder with Single Calculated and Responsive Bid (SCRB) in the Total Amount of Eight Hundred Ninety-three Thousand, Five Hundred Philippine Pesos (Php 893,500.00) for Lot 1: Furniture for e-Library of the project: Purchase of IT Equipment and Furniture for eLibrary Modernization; and*

*to recommend for approval by the President of the Kalinga State University of an award and the foregoing findings.*


