



**A BAC RESOLUTION DECLARING TWO FAILED BIDDINGS AND
RECOMMENDING FOR NEGOTIATED PROCUREMENT**

**RESOLUTION NO. 383, S. 2018
(CIVIL WORKS)**

WHEREAS, in compliance with the provisions of RA 9184, the **Kalinga State University (KSU)** re-posted in the PhilGEPS website (<https://www.philgeps.gov.ph>) on **July 23-31, 2018** the Invitation to Bid (IB) for the conduct of public bidding for the **Construction of HRM Building-Phase IV** with an Approved Budget for the Contract (ABC) amounting to **Nine Hundred Seventy Thousand, Two Hundred Seventy-Five Philippines Pesos (Php 970,275.00)** and posted the same at the KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses, continuously for seven days after its first bidding conducted for the period- June 27, 2018 to July 17, 2018;

WHEREAS, in response to the said **posting/advertisement**, only **CSD Engineering and Construction** has read the IB posted at the conspicuous place of the University while no other bidder has browsed the bidding documents as appeared in the Document Request List (DRL) menu of the PhilGEPS website;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-Bid Conference on August 1, 2018** wherein neither prospective bidders have attended nor Supplemental Bid was issued;

WHEREAS, during the **Receipt and Opening of Bids on August 13, 2018 at 10 A.M.**, CSD Engineering and Construction submitted its bid envelope, however, the BAC declared a postponement of the Opening of Bids due to lack of quorum of BAC members;


WHEREAS, upon the **Resumption of Bid Opening on August 14, 2018 at 1 P.M.**, the TWG recommended to the BAC to declare CSD Engineering and Construction as **"ineligible"** due to the absence of his Construction Equipment Utilization Schedule as required under Item Letter Q of the Eligibility and Technical Documents;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, hereby declare **second failure of biddings for the Construction of HRM Building-Phase IV** due to **"ineligibility"** of CSD Engineering and Construction to pass the technical evaluation of the bidding pursuant to Section 35.1(b) of the 2016 IRR of RA 9184; and to recommend for approval by the Head of Procuring Entity to resort into a Negotiated Procurement under Two-Failed Biddings as provided by Section 53.1 of the 2016 IRR of RA 9184.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.


