A BAC RESOLUTION DECLARING A FAILURE OF BIDDING AND RECOMMENDING FOR RE-BIDDING

RESOLUTION NO. 622, S. 2017 (GOODS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) posted in the PhilGEPS website (https://www.philaeps.gov.ph) on October 22, 2017 to November 2, 2017 the Invitation to Bid for Procurement of Service Utility Vehicle (Ref. No. 264004080300003) with an Approved Budget for the Contract (ABC) amounting to **One Million, Five Hundred Thousand Philippine Pesos (Php 1,500,000.00)** and posted the same at the KSU website (http://ksu.edu.ph), and conspicuous place at the premises of the University continuously for seven days;

WHEREAS, in response to the said posting/advertisement, no bidders have browsed/read the opportunity at the PhilGEPS and KSU websites and BAC Bulletin Board;

WHEREAS, the Bids and Awards Committee and the Technical Working Group for Goods conducted the Pre-bid Conference on November 3, 2017 whereupon no prospective bidders have attended and no Supplemental Bid was issued;

WHEREAS, during the Receipt of Bids on November 15, 2017, no bidders have submitted their bids which resulted to the BAC' declaration of failed bidding;

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED**:

to declare a failure of bidding due to absence of participating bidders pursuant to Section 35.1(a) of the IRR of RA 9184;

to task the TWG for review and evaluation, if necessary, of the technical specifications, terms and conditions to suit the applicable conditions of the project; and

to recommend for approval by the President of Kalinga State University for the conduct of second bidding for the Procurement of Service Utility Vehicle.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
