



A BAC RESOLUTION DECLARING E.T. AMILIG CONSTRUCTION AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 729, S. 2017 (CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) posted in the PhilGEPS website (<http://www.philgeps.gov.ph>) on September 12-19, 2017 the Invitation to Bid (IB) for **Construction of Perimeter Fencing - Rizal Campus (Ref. No. 264004010100016)** with an Approved Budget for the Contract (ABC) amounting to **One Million, Nine Hundred Forty-one Thousand, Two Hundred Thirty Philippines Pesos and Ninety Centavos (Php 1,941,230.90)** and posted the same at the KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University continuously for seven days;

WHEREAS, in response to the said posting/advertisement, three (3) bidders have browsed/read the opportunity at the PhilGEPS website namely: PG Velasco Construction, AZ General Merchandizing, and First Reliable Builders, while one (1) bidder- E.T. Amilig Construction read the IB at KSU website and premises of the University and purchased the bid documents on September 12, 2017;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-bid Conference** on **September 20, 2017** whereupon no bidders have attended and no Supplemental Bid Bulletin was issued;

WHEREAS, during the **Receipt and Opening of Bids on October 2, 2017**, E.T. Amilig Construction submitted its bid, evaluated by the BAC and was declared ineligible due to incomplete and insufficient amount of Single Largest Completed Contract and absence of supporting documents;

WHEREAS, on October 3, 2017, E.T. Amilig Construction filed its motion for reconsideration, was evaluated and resolved by the BAC as denied due to bidder's fault on October 9, 2017;

WHEREAS, the BAC re-published the IB on October 10-17, 2017 with similar ABC, Scope of Works and Contract' Conditions at the required posting sites continuously for seven days;

WHEREAS, in response to the said posting/advertisement, two (2) bidders have browsed/read the opportunity at the PhilGEPS website namely: Hanging Stone Construction, and GNF General Merchandise, while one (1) bidder- E.T. Amilig Construction read the IB at KSU website and premises of the University and availed the bid documents;

WHEREAS, the BAC and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-bid Conference** on **October 18, 2017** whereupon no bidders have attended and no Supplemental Bid Bulletin was issued;

WHEREAS, during the **Receipt and Opening of Bids on October 30, 2017 at 10 am**, E.T. Amilig Construction submitted its bid envelope containing the Eligibility, Technical and Financial Components, and was declared "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the financial bid envelope, to declare the bid of **E.T. Amilig Construction** in the amount of **One Million Nine Hundred Eleven Thousand Three Hundred Five Philippine Pesos and Nine Centavos (Php 1,911,305.09)** as the **Single Calculated Bid (SCB) as Read** subject to the conduct of post qualification evaluation;

to declare the bid of E.T. Amilig Construction as the Single Calculated and Responsive Bid, based on the recommendation of Technical Working Group for Infrastructure Projects; and

to recommend for approval by the Head of the Procuring Entity of the Kalinga State University the award of contract amounting to One Million Nine Hundred Eleven Thousand Three Hundred Five Philippine Pesos and Nine Centavos (Php 1,911,305.09) to E.T. Amilig Construction for Construction of Perimeter Fencing - Rizal Campus.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.


