A BAC RESOLUTION DECLARING RIPPLE BUILDERS, TRADING & CONSTRUCTION SUPPLY AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 465, S. 2017 (CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) posted in the PhilGEPS website (https://www.philgeps.gov.ph) on September 8-11, 2017 the Request for Negotiated Procurement for Construction and/or Rehabilitation of Multi-Purpose Building including Php500,000.00 for Sports' Facilities (Ref. No. RAF01-2017-08-06) with an Approved Budget for the Contract (ABC) amounting to One Million, Four Hundred Fifty-four Thousand, Six Hundred Ninety-seven Philippine Pesos and Fifty-one Centavos (Php 1,454,697.51) and posted the same at the KSU website (http://ksu.edu.ph), and conspicuous place at the premises of the University continuously for three days after conduct of two-failed biddings;

WHEREAS, in response to the said advertisement, three bidders namely: Ripple Builders, Trading & Construction Supply, Blessing Builders and Construction Supply, and TNJ Builders browsed/read the opportunity at the PhilGEPS website and KSU-BAC Bulletin Board and secured bid documents free of charge from the BAC Secretariat;

WHEREAS, during the Receipt, Opening and Evaluation of Bids on September 11, 2017, said three bidders submitted their sealed quotations and upon evaluation of the Bids and Awards Committee (BAC), only TNJ Builders was declared "ineligible" due to incomplete and patently insufficient Omnibus Sworn Statement, while Blessing Builders and Construction Supply and Ripple Builders, Trading & Construction Supply were both "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the Bids and Awards Committee, upon opening the financial bid envelope of both eligible bidders as "complying," declared the bid of Ripple Builders, Trading & Construction Supply in the amount of One Million Four Hundred Fifty-two Thousand Two Hundred Forty-three Philippine Pesos and Forty-one Centavos (Php 1,452,243.41) being the Lowest Calculated Bid (LCB) as Read subject to the conduct of post-qualification evaluation;

WHEREAS, the Technical Working Group for Infrastructure Projects, upon conduct of post-qualification evaluation on September 19, 2017 recommended to the Bids and Awards Committee, to declare the bid of Ripple Builders, Trading & Construction Supply as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**

to declare the bid of Ripple Builders, Trading & Construction Supply as the Lowest Calculated and Responsive Bid, based on the recommendation of Technical Working Group for Infrastructure Projects; and

to recommend for approval by the Head of the Procuring Entity of the Kalinga State University the award of contract amounting to One Million Four Hundred Fifty-two Thousand Two Hundred Forty-three Philippine Pesos and Forty-one Centavos (Php 1,452,243.41) to Ripple Builders, Trading & Construction Supply for Negotiated Procurement for Construction and/or Rehabilitation of Multi-Purpose Building including Php500,000.00 for Sports' Facilities.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
