# A BAC RESOLUTION DECLARING GOLDEN ASIA AUTOMOTIVE BUILDERS INC. AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT

### **RESOLUTION NO. 432, S. 2017** *(GOODS)*

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) published in the PhilGEPS website (https://www.philgeps.gov.ph) on June 29, 2017 to July 19, 2017 the Invitation to Bid (IB) for the conduct of public bidding for Procurement of Coaster Vehicle (Ref. No. 264004080300004) with an Approved Budget for the Contract (ABC) amounting to Four Million Philippine Pesos (Php 4,000,000.00) and posted the same at the KSU website (http://ksu.edu.ph), and conspicuous place at the premises of the University continuously for seven days;

WHEREAS, in response to the said advertisement, a bidder's representative from RDAK Transport Equipment Incorporated attended a Pre-bid Conference on July 7, 2017 but did not submit its proposals on July 19, 2017 Receipt and Opening of Bids, and the BAC declared a failure of bidding pursuant to Section 35.1(a) of the Revised IRR of RA 9184;

**WHEREAS**, upon request of the BAC, the TWG revised the terms, conditions and specifications in the Bidding Documents to attract prospective bidders;

**WHEREAS**, an IB for **Procurement of Coaster Vehicle** with the same ABC was re-advertised at the required sites on <u>July 23, 2017 to August 1, 2017</u> which was responded by a bidder's representative of Golden Asia Automotive Corporation;

WHEREAS, during the Receipt and Opening of Bids held on <u>August 14, 2017</u>, no bidders submitted their bids whereupon the BAC, upon recommendation of the Technical Working Group for Vehicles, declared on the same day a Two-Failed Biddings and recommended for Negotiated Procurement;

WHEREAS, on <u>August 14, 2017</u>, the HOPE approved BAC Resolution No. 366, Series of 2017 for a **Negotiated Procurement for Purchase of One Unit Coaster Vehicle** with an **ABC of Four Million Philippine Pesos (Php 4,000,000.00)** through Request for Quotation posted on <u>August 16-21, 2017</u> at PhilGEPS website, KSU website, conspicuous places at the premises of the University Campuses including BAC Bulletin Board aside from RFQ manually floated by Canvasser;

**WHEREAS**, in response to the RFQ, the following three (3) Suppliers have submitted their sealed quotation before the scheduled bid submission:

to recommend for approval by the Head of the Procuring Entity of an award/purchase order;
