



A BAC RESOLUTION DECLARING TNJ BUILDERS AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 430, S. 2017
(CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) advertised in the PhilGEPS website (<https://www.philgeps.gov.ph>) on July 25, 2017 to August 2, 2017 the **Invitation to Bid (IB)** for the conduct of public bidding for **Construction of Science and Technology Processing Center (Ref. No. 264004010100017)** with an Approved Budget for the Contract (ABC) amounting to **Five Million, Eight Hundred Twenty Thousand, One Hundred Seventy-nine Philippine Pesos and Fifty-one Centavos (Php 5,820,179.51)** and posted the same at the KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University continuously for seven days;

WHEREAS, in response to the said posting/advertisement, five (5) bidders browsed/read the opportunity at the PhilGEPS website including HGW=3 Engineering & Construction and First Reliable Builders who attended the **Pre-bid Conference on August 3, 2017** together with TNJ Builders and the Joint Venture of LAB Engineering and I.P. Lacwasan Construction & Development Corporation whereupon **Supplemental Bid/Bulletin No. 01 dated August 7, 2017** was issued regarding amendments and clarifications on the different sections of bid documents;

WHEREAS, three bidders: TNJ Builders, HGW=3 Engineering & Construction, and Joint Venture of LAB Engineering and I.P. Lacwasan Construction & Development Corporation have purchased the bidding documents on August 2 & 4, 2017 respectively but during the **Receipt and Opening of Bids on August 15, 2017 at 10 a.m.**, only one bidder - TNJ Builders has submitted its bid, declared eligible and passed the technical evaluation of the bidding;

WHEREAS, the Technical Working Group for Infrastructure Projects recommended to the Bids and Awards Committee, upon opening the financial bid envelope, to declare the bid of TNJ Builders in the amount of **Five Million, Seven Hundred Ninety-four Thousand, Two Hundred Fourteen Philippine Pesos and Sixty-nine Centavos (Php 5,794,214.69)** as "complying" as to its financial document subject for post qualification evaluation;

WHEREAS, the TWG-Infra, upon conduct of post qualification on August 19, 2017 with consideration of the previously conducted ocular inspection for Construction of One-Storey School Building of the lone bidder's similar declared Single Largest Completed Contract which is the Multipurpose Building at Buluan, Conner, Apayao last July 5, 2017, recommended to the BAC to declare the bid of TNJ Builders as Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**

to declare the bid of TNJ Builders as the Single Calculated and Responsive Bid, based on the recommendation of Technical Working Group for Infrastructure Projects; and

to recommend for approval by the Head of the Procuring Entity of the Kalinga State University the award of contract amounting to Five Million, Seven Hundred Ninety-four Thousand, Two Hundred Fourteen Philippine Pesos and Sixty-nine Centavos (Php 5,794,214.69) to TNJ Builders for Construction of Science and Technology Processing Center.
