



A BAC RESOLUTION DECLARING PMD CONSTRUCTION & SUPPLIES AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 323, S. 2018 (CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the **Kalinga State University (KSU)** posted in the PhilGEPS website (<https://www.philgeps.gov.ph>) on **June 1-20, 2018** the Invitation to Bid (IB) for **Construction/Repair/Rehabilitation of Academic Building/Contract Reference Number ITB2018-05-0031** with an Approved Budget for the Contract of **Four Million, Eight Hundred Fifty-Three Thousand, Five Hundred Eighty-Five Philippines Pesos and Four Centavos (Php4,853,585.04)** and posted the same at the KSU website (<https://ksu.edu.ph/good-governance/invitebid>), and conspicuous place at the premises of the University Campuses, continuously for seven days until bid submission and receipt;

WHEREAS, in response to the posting/advertisement, five (5) bidders namely: **FRAGERR CONSTRUCTION, JESSIE JAMES GENERAL CONSTRUCTION AND ENGINEERING SERVICES, AZ GENERAL MERCHANDIZING, GNF GENERAL MERCHANDISE, and PMD CONSTRUCTION & SUPPLIES** browsed/read the IB at the PhilGEPS website, KSU website and conspicuous places at the premises of the University and the last bidder availed the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the **Pre-Bid Conference** on **June 8, 2018** whereupon Supplemental Bid Bulletin No. 1 dated June 13, 2018 was issued regarding amendments and clarifications in the bid documents;

WHEREAS, during the **Submission and Receipt of Bids on June 20, 2018**, the lone bidder- **PMD Construction & Supplies** submitted its bid envelope containing technical and eligibility documents and financial proposal;

WHEREAS, the BAC, upon recommendation of the TWG-Infra declared that **PMD Construction & Supplies** is **"eligible"** and passed the technical evaluation of the bidding subject to the conduct of post qualification evaluation;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the financial bid envelope, to declare the bid of **PMD Construction & Supplies** in the amount of **FOUR MILLION, EIGHT HUNDRED NINE THOUSAND, ONE HUNDRED TWENTY-SEVEN PHILIPPINE PESOS AND EIGHTEEN CENTAVOS (PhP 4,809,127.18)** as the Single Calculated Bid As Read subject to the conduct of post qualification evaluation;

WHEREAS, the TWG-Infra, upon conduct of **Post Qualification** evaluation by its designated members on **June 21, 2018**, recommended to the BAC, to declare the bid of **PMD Construction & Supplies** as the **Single Calculated and Responsive Bid (SCRB)**;


WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects, hereby declare the bid of **PMD Construction & Supplies** as the Single Calculated and Responsive Bid pursuant to Section 34.4 of the 2016 IRR of RA 9184 and recommends for approval by the Head of the Procuring Entity through the University President to award the contract amounting **FOUR MILLION, EIGHT HUNDRED NINE THOUSAND, ONE HUNDRED TWENTY-SEVEN PHILIPPINE PESOS AND EIGHTEEN CENTAVOS (PhP 4,809,127.18)** for the **Construction/Repair/Rehabilitation of Academic Building**.



RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.




