



## A BAC RESOLUTION DECLARING TWO FAILED BIDDINGS AND RECOMMENDING FOR NEGOTIATED PROCUREMENT

### RESOLUTION NO. 555, S. 2018 (GOODS)

**WHEREAS**, in compliance with the provisions of RA 9184, the **Kalinga State University (KSU)** re-posted in the PhilGEPS website (<https://www.philgeps.gov.ph>) on October 10-30, 2018 the Invitation to Bid (IB) for the conduct of public bidding for **Purchase of Various Laboratory Equipment** with an Approved Budget for the Contract (ABC) amounting to **One Million One Hundred Twenty-Three Thousand Three Hundred Fifty-Two Philippine Pesos (Php1,123,352.00)** and posted the same at the KSU website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses, continuously for seven days after **its first failed bidding** conducted for the period: **August 10-30, 2018:**

**WHEREAS**, in response to the said **advertisement**, eleven (11) prospective bidders browsed/read the posting opportunity at the **PhilGEPS Website, KSU Website and Bulletin Boards**, and have downloaded the bidding documents, namely: (1) MEDICAL CENTER TRADING CORPORATION, V.G. ROXAS COMPANY, INC., 3M PHILIPPINES INC., HADIA TRADING INC., ENDURE MEDICAL, INC., JM IBAÑEZ ENTERPRISE, HYTEC POWER, INC., GOLDEN BAT ( FAR EAST ), INC., ITS SCIENCE (PHILS), INC., RS IT SOLUTIONS, and BIOTRIUNE, INC.;

**WHEREAS**, the BAC and the Technical Working Group for Goods (TWG-Goods) conducted the **Pre-Bid Conference on October 18, 2018 @ 10 am** with the prospective bidder (only RS IT Solutions' representatives have attended) whereupon **Supplemental Bid Bulletin (SBB) No. 1 dated October 22, 2018** was issued regarding amendments and clarifications in the bid documents;

**WHEREAS**, on **October 29, 2018**, the **Provincial Government of Kalinga** suspended the classes and works in private and public agencies through its **Executive Order No. 34** which prompted the **BAC** to declare a **postponement of the Receipt and Opening of Bids from October 30, 2018 to November 5, 2018 at 10 am**, with posting of Supplemental Bid Bulletin for its postponement at PhilGEPS and KSU websites and conspicuous places of the University;

**WHEREAS**, during the **Receipt and Opening of Bids on November 5, 2018 at 10 am**, **no bidders have submitted their bids** and the BAC declared another failed biddings upon recommendation of the TWG-Goods;

**WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED**, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Goods, **hereby declare two-failed biddings for the Purchase of Various Laboratory Equipment due to non-receipt of bids pursuant to Section 35.1(a) of the 2016 IRR of RA 9184; and to recommend to the Head of Procuring Entity through the University President to resort to Negotiated Procurement through Two-Failed Biddings modality as provided for in Section 53.1 of the IRR.**


**RESOLVED FINALLY**, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.


