A BAC RESOLUTION DECLARING POST QUALIFIED BIDDER AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 735, S. 2018 (GOODS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) through the Bids and Awards Committee (BAC) posted in the PhilGEPS website (https://www.philgeps.gov.ph) on November 25, 2018 to December 4, 2018 the Invitation to Bid (IB) for the conduct of public bidding for the Purchase and Delivery of Furniture, Fixtures and Equipment for ISO Certification with an Approved Budget for the Contract (ABC) amounting to Two Million, Three Hundred Thousand Philippines Pesos (Php 2,300,000.00) sourced from Internally Generated Income Fund CY 2018 and posted the same at the KSU website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses, continuously for seven days;

WHEREAS, in response to the said advertisement/posting, there are eight (8) prospective bidders who browsed/read the bid documents namely: Myz Alta Muebles Enterprises, GNF General Merchandise, Officelux Interior, Cubixoffice Inc., Real Form Furniture Shop, Style and Comfort Marketing Services, Aspen Multi-system Corporation, and Northlandia Enterprises – Santiago City;

WHEREAS, the BAC and the Technical Working Group for Goods related Supplies and Materials (TWG-Goods) conducted the Pre-Bid Conference on December 5, 2018 @ 10am with the prospective external providers specifically representatives from GNF General Merchandise whereupon Supplemental Bid Bulletin No. 01 dated December 7, 2018 was issued regarding amendments and clarifications in the bid documents and Technical Specifications;

WHEREAS, during the **Receipt and Opening of Bids on December 17, 2018 @ 10AM**, only Real Form Furniture Shop has purchased the bidding documents, submitted its proposals, and was evaluated by the BAC and TWG as "eligible" after passing the technical evaluation of the bidding;

WHEREAS, the TWG-Goods recommended to the BAC, upon opening the financial bid envelope, to declare the bid of Real Form Furniture Shop in the amount of Two Million Two Hundred Ninety-Seven Thousand Nine Hundred Sixty-Five Philippine Pesos (Php 2,297,965.00) as the Single Lowest Calculated Bid (SCB) subject to the motion of adopting the previous post qualification evaluation conducted to the same bidder on JANUARY 24, 2018 for the KSU's two (2) Projects: 1) Acquisition of Furniture and Fixtures for Administration, Accounting and Registrar's Offices; and 2) Procurement of Furniture and Fixtures for Computer Laboratories:

WHEREAS, the TWG-Goods, upon consideration and re-assessment of the post-qualification evaluation conducted to the same bidder to be practical and advantageous to the Procuring Entity in terms of time and resources, recommended to the BAC **to declare the bid of Real Form Furniture Shop as the Single Calculated and Responsive Bid (SCRB)**;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Goods related Supplies and Materials, hereby recommends for approval by the University President to declare the bid of Real Form Furniture Shop as the Single Calculated Responsive Bid (SCRB) and to award the contract amounting to Two Million Two Hundred Ninety-Seven Thousand Nine Hundred Sixty-Five Philippine Pesos (Php 2,297,965.00) for the Purchase and Delivery of Furniture, Fixtures and Equipment for ISO Certification.

RESOLVED FINALLY, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
