**A RESOLUTION RECOMMENDING ALTERNATIVE METHOD OF PROCUREMENT THROUGH SHOPPING AND RECOMMENDING FOR AWARD**  
*(for ABCs with >Php 50,000.00 and ≤ Php 200,000.00)*

**BAC Resolution No. 489, s. 2017**

WHEREAS, the Kalinga State University (KSU) seeks to attain economy and efficiency in all aspects of its procurement operations by resorting to the above-mentioned Alternative Method of Procurement consistent with Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the KSU-BAC was tasked to evaluate the Purchase Request No. 207-09-0657, for the purchase of goods;

WHEREAS, said items are included and conformed to the approved budget of the end-user's Project Procurement Management Plan (PPMP), and KSU Annual Procurement Plan (APP) for CY 2016;

WHEREAS, the following are the reasons for the purchase of said goods:

- 1. That the amount involved is above Php50,000.00 but below Php200,000.00 which is an small amount to justify the conduct of public bidding and within the thresholds prescribed in Annex "H" of the 2016 Revised IRR of R.A. 9184 for SUCs.
- 2. That there is unforeseen contingency requiring immediate purchase of the goods.
- 3. The goods are not available/offered/out of stock at the DBM Procurement Service.
- 4. That procurement of these goods do not fall under the prohibition on "Splitting of Government Contracts."
- 5. KSU has ensure that the objectives and purpose of the contract do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure.
- 6. That the BAC shall validate the technical, legal and financial capability of the supplier(s) by requiring the submission of relevant documents or through other means prior to recommendation of award to the HOPE.

NOW THEREFORE, we the Members of the BAC, hereby RESOLVE AS IT HEREBY RESOLVED:

**to recommend Alternative Method of Procurement through Shopping as provided in Sec. 52.1(a) and the Consolidated Guidelines for the Alternative Methods of Procurement of the Annex "H" of the Revised IRR of R.A. 9184 for the above-cited goods/services; and**

**to recommend the award and approval by the KSU President of this Resolution and Purchase Order to the bonafide Supplier(s) indicated in the Abstract of RFQ/Canvass.**
