	<ol><li>That the BAC, through its Secretariat, shall post the RFQ/Canvass for 3 calendar days and Notice of Award/ Purchase Order in the PhilGEPS, KSU websites and at any conspicuous place reserve for this purpose in the premises of the University for information and transparency purposes.</li></ol>
	3. The goods are not available/offered/out of stock at the DBM Procurement Service.
1/	4. That procurement of these goods does not fall under the prohibition on "Splitting of Government Contracts."
	<ol><li>KSU has ensured that the objectives and purpose of the contract do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure.</li></ol>
