

CONTRACT AGREEMENT

THIS AGREEMENT made the 10th day of December 2018 between **KALINGA STATE UNIVERSITY** of the Philippines hereinafter called "the Entity" of the one part and **URSP CERTIFICATION SERVICES** of Lot 39&41, Blk. 6, Phase 1, Lavanya Subdivision, Gen. Trias City, Cavite, 4107 Philippines hereinafter called "the Service Provider" of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PROCUREMENT OF SERVICES OF ISO CERTIFYING BODY** and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of **TWO HUNDRED FIFTY THOUSAND PHILIPPINE PESOS (PHP250,000.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Project Procurement Management Plan;
 - (b) Summary and Detailed Estimates;
 - (c) Approved Budget for the Contract;
 - (d) Program of Works;
 - (e) Budget Request;
 - (f) Advertisement and/or posting of Request for Quotation including Terms and Conditions/Instructions to Bidders, and Scope of Works;
 - (g) Contractors' Bid Forms including the required Eligibility, Technical and Financial Documents, which include the following:
 - A. Financial Documents:
 - i. Bill of Quantities,
 - ii. Summary and Detailed Estimates, and
 - iii. Schedule/Standard Computation.
 - B. Eligibility/Legal Documents:
 - i. PhilGEPS Registration Number,
 - ii. CY 2018 Mayor's/Business Permit,
 - iii. Notarized Omnibus Sworn Statement; and
 - iv. Company Profile including the following documents:
 - a. List of Completed related projects.
 - b. Professional License and Curriculum Vitae.
 - (h) Abstract of Sealed Quotation, Arithmetic Bid Evaluation and Post Qualification Report;
 - (i) BAC Resolution recommending award of Contract;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.


3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Service Provider in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


