

## CONTRACT AGREEMENT

THIS AGREEMENT made the 29<sup>th</sup> day of November 2018 between **KALINGA STATE UNIVERSITY** of the Philippines hereinafter called "the Entity" of the one part and **MAZAN SECURITY & INVESTIGATION AGENCY** of #1 Sunkist, Sunshine Valley Homes, Pengue Ruyu, Tuguegarao City, Cagayan, Philippines hereinafter called "the Service Provider" of the other part.


WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **PROVISION OF SECURITY SERVICE FOR UNIVERSITY 3 CAMPUSES** and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of **THREE HUNDRED SIX THOUSAND THREE HUNDRED TWENTY-SEVEN PHILIPPINE PESOS (PHP 306,327.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Service Provider's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted *e.g.* bidder's response to clarifications on the bid, including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the Terms of Reference of the Request for Quotation;
  - (e) the Terms and Conditions of Contract;
  - (f) the Performance Security;
  - (g) the Labor Bond;
  - (h) the Entity's Notice of Award; and
  - (i) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Service Provider in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.






