WHEREAS, the Entity is desirous that the Contractor execute CONCRETING OF ROAD NETWORK/ REQUEST FOR QUOTATION NUMBER RFQ_CIVILWORKS_2018-10-48 hereinafter called "the Works" and the Entity has accepted the Bid for LOWEST CALCULATED RESPONSIVE BID (LCRB) AT A CONTRACT PRICE OF SEVEN HUNDRED SEVENTY-TWO THOUSAND ONE HUNDRED FIFTEEN PHILIPPINE PESOS AND NINETY-THREE CENTAVOS (Php 772,115.93) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - ii. Summary and Detailed Estimates;
 - iii. CY 2018 Mayor's/Business Permit;
 - iv. PhilGEPS Registration Number;
 - v. PCAB License:
 - vi. Income/ Business Tax Return, and
 - vii. Omnibus Sworn Statement.
 - (h) Abstract of Sealed Quotation and Arithmetic Bid Evaluation;
 - (i) BAC Resolution recommending award of Contract;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Contractor's Performance Security; and
 - (I) Other contract documents that may be required by existing laws and/or the Entity.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
