

# CONTRACT AGREEMENT

THIS AGREEMENT, made this 25<sup>th</sup> day of October 2018 between **KALINGA STATE UNIVERSITY** with principal office address at National Highway, Purok 6, Bulanao Centro, Tabuk City, Kalinga hereinafter called the "**Entity**" and **CSD ENGINEERING AND CONSTRUCTION** with office address at Purok 1, Babalag West, Rizal, Kalinga hereinafter called the "**Contractor**."

WHEREAS, the Entity is desirous that the Contractor execute **CONSTRUCTION OF COVERED PATHWAY AT KSU RIZAL CAMPUS/ Contract Reference Number RFQ2018-10-0041** hereinafter called "**the Works**" and the Entity has accepted the Bid for **FOUR HUNDRED EIGHTY-EIGHT THOUSAND SEVENTY PHILIPPINE PESOS AND FIFTY-NINE CENTAVOS (PHP 488,070.59)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) Advertisement/ Request for Quotation including Terms and Conditions and Annexes;
  - (b) Detailed Estimates;
  - (c) Approved Budget for the Contract;
  - (d) Program of Works;
  - (e) Purchase Request;
  - (f) Drawings/Plans/Perspective;
  - (g) Scope of Works;
  - (h) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (i) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (j) Eligibility requirements, documents and/or statements;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Performance Security; and
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
