CONTRACT AGREEMENT

THIS AGREEMENT, made this 18th day of December 2017 between KALINGA STATE UNIVERSITY with principal office address at National Road, Purok 6, Bulanao, City of Tabuk, Kalinga hereinafter called the "Entity" and CSD ENGINEERING AND CONSTRUCTION with office address at Purok 1, Babalag West, Rizal, Kalinga hereinafter called the "Contractor."

WHEREAS, the Entity is desirous that the Contractor execute COMPLETION OF LIBRARY BUILDING - RIZAL CAMPUS / CONTRACT REFERENCE NUMBER 264004010100019 hereinafter called "the Works" and the Entity has accepted the Bid for Nine Million Ninety Eight Thousand Nine Hundred Sixteen Philippine Pesos and Five Centavos (Php9,098,916.05) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are 1. respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - Bid form, including all the documents/statements contained in the Bidder's (h) bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - Eligibility requirements, documents and/or statements; (i)
 - Notice of Award of Contract and the Bidder's conforme thereto; (j)
 - (k) Performance Security;
 - Contractor's All Risk Insurance Policy; (|)
 - Construction safety and health program approved by the Department of (m) Labor and Employment; and
 - Other contract documents that may be required by existing laws and/or the (n) Entity.

- The Entity hereby covenants to pay the Contractor in consideration of the 4. execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
