



CONTRACT AGREEMENT

THIS AGREEMENT, made this <u>16th day of October 2018</u> between **KALINGA STATE UNIVERSITY** with principal office address at National Road, Purok 6, Bulanao, City of Tabuk, Kalinga hereinafter called the "Entity" and **GALLICA CONSTRUCTION** with office address at Antonio Canao, Lubuagan, Kalinga hereinafter called the "Contractor."

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF KSU MUSHROOM BUILDING- PHASE II/ Request for Quotation Number RFQ2018-08-0777 hereinafter called "the Works" and the Entity has accepted the Bid for FOUR HUNDRED EIGHTY-THREE THOUSAND ONE HUNDRED EIGHTY-FIVE PHILIPPINE PESOS AND FORTY-TWO CENTAVOS (Php 483,185.42) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Project Procurement Management Plan;
 - (b) Summary and Detailed Estimates;
 - (c) Approved Budget for the Contract;
 - (d) Program of Works;
 - (e) Purchase Request;
 - (f) Request for Quotation including Terms and Conditions/Instructions to Bidders, Scope of Works and Drawing/Plan;
 - (g) Contractors' Bid Forms including the required Eligibility, Technical and Financial Documents, which include the following:
 - i. CY 2018 Mayor's/Business Permit;
 - ii. PhilGEPS Registration Number;
 - iii. PCAB License;
 - iv. Income/Business Tax Return; and
 - v. Omnibus Sworn Statement.
 - (h) Abstract of Sealed Ouotation:
 - (i) BAC Resolution recommending award of Contract;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Contractor's Performance Security; and
 - (I) Other contract documents that may be required by existing laws and/or the Entity.



- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
