WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University published an Invitation to Bid at the PhilGEPS website, KSU website, and conspicuous place at the premises of KSU for the **Construction of Kalinga Livelihood Museum and KSU Alumni Center Phase II** with an approved budget of **Php1,164,771.91** from February 25, 2016 to March 15, 2016;

WHEREAS, on the afternoon of March 16, 2016, the BAC and TWG conducted a Post-Qualification Investigation specifically ocular inspection of the bidder's one declared single similar project which is the Tourism Building at the Kalinga Provincial Capitol and the Bidder is compliant as to finding;

WHEREAS, on March 17, 2016, the BAC and TWG continued the Post Qualification Process, which includes careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Lowest Calculated Bidder, and noted that in the duly signed Bid Form of the Bidder under Letter D, **a discount was offered at 1%** but no methodology of application was discussed;

WHEREAS, Section 32.2.4 of R.A. 9184 and its revised IRR, including its associated issuances, such as the PBDs, recognizes the consideration of bid modifications in the computation of the bid price which may be in the form of discounts offered either as part of the financial document or through the Bid Form;

WHEREAS, ITB Clause 28.4 of the PBDs for the Procurement of Infrastructure Projects provides that the determination of the Lowest Calculated Bid requires the evaluation and correction for computational errors, discounts and other modifications;

WHEREAS, since the bidder's offered discount of 1% does not qualify the methodology of its application, this can be presumed that the discount will apply to the whole amount of the identified bid price by deducting one percent (1%) from Php981,102.06 which equals to Php971,291.04 final bid price;

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby RESOLVE AS IT IS HEREBY RESOLVED:

to declare Equip Construction as Post Qualified being the Bidder with the Lowest Calculated Responsive Bid with an offer of Nine Hundred Seventy-one, Two Hundred Ninety-one Philippine Pesos and Four Centavos (Php971,291.04) for the Construction of Kalinga Livelihood Museum and KSU Alumni Center Phase II; and


to recommend for approval by the President of the Kalinga State University of an award and the foregoing findings.




