



A BAC RESOLUTION DECLARING LCRB AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 214, S. 2017
(INFRA)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University advertised in the PhilGEPS website, KSU website, BAC Bulletin Board, and conspicuous place at the premises of the University the Invitation to Bid of the Project, "Completion of Alumni Center (2nd Bidding)" continuously from March 23-30, 2017;

WHEREAS, in response to the said advertisement, three bidders, namely: E.T. Amilig Construction, Equip Construction, and Lincee General Construction and General Merchandise purchased bid documents and participated during the Opening of Bids conducted on April 12, 2017;

WHEREAS, during the Evaluation of Bids, Equip Construction was declared ineligible due to non-inclusion of two (2) key personnel in its eligibility and technical documents;

WHEREAS, the financial proposals of the two remaining bidders as read and evaluated were as follows:

Bidder	As read and calculated	Variance to ABC
E.T. AMILIG CONSTRUCTION	Php 1,910,607.35	1.67 % lower
LINCEE GENERAL CONSTRUCTION AND GENERAL MERCHANDISE	Php 1,924,273.09	0.97 % lower

WHEREAS on April 24, 2017, the BAC resolved and denied the motion for reconsideration filed by Equip Construction on April 17, 2017 citing that non-inclusion of Sanitary and Electrical Engineers as key personnel in its technical documents is considered missing, incomplete or insufficient bid;

WHEREAS, the BAC and its TWG conducted a post-qualification on April 18, 2017 and found that E.T. Amilig Construction complied with and was responsive to all the requirements and conditions as specified in the Bidding Documents;

WHEREAS per coordination on May 2, 2017 with the Office of the HOPE, Equip Construction did not file its protest after they received the notice on April 24, 2017 denying their motion;

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**


to declare E.T. Amilig Construction as post qualified, being the bidder with Lowest Calculated and Responsive Bid (SLCRB) in the Total Amount of One Million, Nine Hundred Ten Thousand, Six Hundred Seven Philippine Pesos and Thirty-five Centavos (Php1,910,607.35) for Completion of Alumni Center (2nd Bidding); and


to recommend for approval by the President of the Kalinga State University of an award and the foregoing findings.

RESOLVED FINALLY, to post this Resolution at the KSU Website, PhilGEPS, other conspicuous place at the premises of the University including the BAC Bulletin Board.




