



Invitation to Bid for Construction of Four Storey Academic Building- Phase II-Bulanao Campus

1. The **Kalinga State University (KSU)**, through the **General Appropriations Act (GAA) Capital Outlay (CO) CY 2018** duly approved by the Board of through Board Resolution No. 1464, Series of 2017 intends to apply the sum of **Twenty-Six Million, Eight Hundred Fifty-Six Thousand, Three Hundred Ninety-Five Philippines Pesos and Twenty-Six Centavos (Php26,856,395.26)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Four Storey Academic Building-Phase II-Bulanao Campus/ 100200018000**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Kalinga State University** now invites bids for the **Construction of Four Storey Academic Building-Phase II-Bulanao Campus**. Completion of the Works is required **until December 31, 2018 only upon receipt of the Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **Kalinga State University** and inspect the Bidding Documents at the address given below from **8 am to 5 pm office hours**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **March 6, 2018 (Tuesday) until 10:00 AM of March 26, 2018 (Monday)** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-five Thousand Philippine Pesos (Php 25,000.00)***.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity at <http://ksu.edu.ph/good-governance/invitebid>, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Kalinga State University** will hold a Pre-Bid Conference on **March 14, 2018 (Wednesday), 10:00 AM at Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 26, 2018 (Monday) at 10:00 AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.



Bid opening shall be on **10:01 AM of March 26, 2018 (Monday) at Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Bidders should comply with the applicable provisions of Section 23.4.2 of the IRR of R.A. 9184 and with a modified set of requirements integrating eligibility documents and criteria for infrastructure projects as provided in Annex E of the 2016 IRR of R.A. 9184, or the **Contract Implementation Guidelines for the Procurement of Infrastructure Projects**.
9. The **Kalinga State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
