Invitation to Bid for Construction/Repair/Rehabilitation of Academic Building

1. The Kalinga State University (KSU), through the General Appropriations Act CY 2018 intends to apply the sum of Four Million, Eight Hundred Fifty-Three Thousand, Five Hundred Eighty-Five Philippines Pesos and Four Centavos (Php4,853,585.04) being the Approved Budget for the Contract (ABC) to payments under the following package contracts for Construction/Repair/Rehabilitation of Academic Building/ITB2018-05-0031. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The Kalinga State University now invites bids for the Construction/ Repair/ Rehabilitation of Academic Building. Completion of the Works is required within 180 calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- **3.** Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from **Kalinga State University** and inspect the Bidding Documents at the address given below from **8 am to 5 pm office hours**.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on **June 1, 2018** (Friday) until 10 AM of June 20, 2018 (Wednesday) from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Philippine Pesos** (Php 5,000.00).

- 6. The Kalinga State University will hold a Pre-Bid Conference on June 8, 2018 (Friday), 10:00 AM at Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or **before June 20, 2018** (Wednesday) at 10:00 AM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 10:01 AM of June 20, 2018 (Wednesday) at Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao Centro, Tabuk City, Kalinga. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. Bidders should comply with the applicable provisions of Section 23.4.2 of the IRR of R.A. 9184 and with a modified set of requirements integrating eligibility documents and criteria for infrastructure projects as provided in Annex E of the 2016 IRR of R.A. 9184, or the Contract Implementation Guidelines for the Procurement of Infrastructure Projects.
- 9. The **Kalinga State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
