Invitation to Bid for PROCUREMENT OF SECURITY SERVICES FOR 11 MONTHS

- 1. The Kalinga State University (KSU), through the Government of the Philippines through the General Appropriations Act FY 2019 and Internally Generated Income Fund CY 2019 intends to apply the sum of Two Million Five Hundred Seventy-Four Thousand Philippine Pesos (Php2,574,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Security Services for 11 Months/ IB_Goods_2019-01-002. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Kalinga State University now invites bids for Procurement of Security Services for 11 Months. Delivery of the Goods (Services) is required within Eleven (11) Months: February 1, 2019 to December 31, 2019 upon receipt of the Notice to Proceed in accordance with the Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from Kalinga State University and inspect the Bidding Documents at the address given below during office hours from 8 am to 5 pm.
- **5.** A complete set of Bidding Documents may be acquired by interested Bidders on January **7**, **2019** (Monday) until 10:00 AM of January **28**, **2019** (Monday) from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of (Five Thousand Philippine Pesos (Php5,000.00).
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity at https://ksu.edu.ph/goodgovernance/invitebid, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The Kalinga State University will hold a Pre-Bid Conference on January 16, 2019 (Wednesday), 10:00 AM at Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao Centro, Tabuk City, Kalinga, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 10:00 AM on January 28, 2019 (Monday). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The **Kalinga State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
