Invitation to Bid for PURCHASE AND DELIVERY OF PE UNIFORMS AND ID LACE FOR STUDENTS' USE

- 1. The Kalinga State University (KSU), through its Business Type Income Fund CY 2019 intends to apply the sum of One Million One Hundred Thirty-Four Thousand Five Hundred Philippine Pesos (Php1,134,500.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Purchase and Delivery of PE Uniforms and ID Lace for Students' Use/ IB_Goods_2019-01-013. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Kalinga State University now invites bids for Procurement of One Unit Commuter Van. Delivery of the Goods (Services) is required within Thirty (30) calendar days upon receipt of the Purchase Order or Notice to Proceed in accordance with the Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from **Kalinga State University** and inspect the Bidding Documents at the address given below **during office hours from 8 am to 5 pm**.
- **5.** A complete set of Bidding Documents may be acquired by interested Bidders on January 28, 2019 (Monday) until 10:00 AM of February 18, 2019 (Monday) from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of (Five Thousand Philippine Pesos (Php5,000.00).
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity at https://ksu.edu.ph/good-governance/invitebid, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The Kalinga State University will hold a Pre-Bid Conference on February 6, 2019 (Wednesday), 10:00 AM at Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao Centro, Tabuk City, Kalinga, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 10:00 AM on February 18, 2019 (Monday). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 - Bid opening shall be on 10:01 AM on February 18, 2019 (Monday) at the Conference Hall, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao Centro, Tabuk
