Evaluation of Bids will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184). <hr/> Further, Evaluation of bids and award of contract shall be based on lowest offer per lot basis. The bidder’s offer for each lot should not exceed the following Approved Budget for the Contract (ABC): <ol style="list-style-type: none"> i. Lot A: ICT Infrastructure Network = ABC: Php5,125,250.00; and ii. Lot B: Various ICT Equipment, Peripherals and Accessories = ABC: Php2,946,750.00. 3. Checklist for Eligibility, Technical and Financial Components is attached as Annex “A”. 4. Bill of Quantities is attached as Annex “B”. 5. Schedule of Requirements is attached as Annex “C”. 6. Any missing, incomplete or patently insufficient document in the checklist is a ground for outright rejection (non-complying) of the bid. b. Technical and Financial Envelopes are preferably soft bounded and with Ear-Tabbing for each Checklist, for easier bid evaluation. Ring bounded is discouraged. c. Each and every page of the Documents comprising the Financial Proposal shall be signed by the bidder or his/her duly authorized representative/s. Failure to do so shall be a ground for the rejection of the bid. 9. SLCC shall refer to Purchase/Delivery/Installation of ICT Equipment with Peripherals, Installation, Configuration and Training, 50% of the ABC per lot. <hr/> <i>For statement of SLCC, the supporting documents stated in the said form shall be submitted during opening of bids/evaluation.</i> 10.
