On 2<sup>nd</sup> Stanza of Paragraph No. 1 of the Invitation to Bid under Section I-Invitation to Bid, page 4, the following is the addendum:

1. The ..."

Bidders shall have the option of submitting a proposal on any lot or all lots based on the specialization of the supplier. If the Bidder opts to bid for more than one lot, only one set of eligibility requirements shall be submitted. Evaluation and award of contract will be undertaken per item basis; however, for bidder that bids to more than one lot and determined to have the Lowest Calculated Responsive Bid per lot shall be awarded with only one contract. Bids received in excess of the ABC per lot shall be automatically rejected at bid opening.

On the Delivery Schedule of Items, there are revisions on the following pages of the published Bid Documents:

- > Page 4: On Paragraph No. 2 of the Invitation to Bid under Section I-Invitation to Bid, and
- > Page 47: On Schedule of Requirements under Section VI of the bid documents.
  - "... Delivery of the Goods is required within Fifteen (15) Forty-Five (45) calendar days upon receipt of the Purchase Order ..."

On ITB Clause No. 28.3(a) of the Bid Data Sheet under Section III-Bid Data Sheet, page 30, the following are the revisions:

#### Grouping and Evaluation of Lots -

All items to be grouped together to form one complete Lot that will be awarded to one Bidder to form one complete contract.

Partial bid is not allowed. The goods are grouped in One Lot and shall not be divided into sub-lots for the purpose of bidding, evaluation, and contract award.

Partial bids are allowed. All Goods are grouped in lots listed below. Bidders shall have the option of submitting a proposal on any or all lots and evaluation and contract award will be undertaken on a per lot basis. Lots shall not be divided further into sub-lots for the purpose of bidding, evaluation, and contract award.

In all cases, the NFCC computation, if applicable, must be sufficient for all the lots or contracts to be awarded to the Bidder.

Quotation for EACH ITEM within a lot shall still be indicated.
